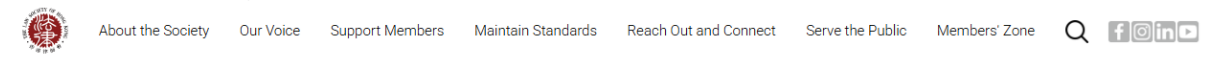

LAW FIRM ACCOUNT

1. No application is available on the application page. What should I do?

3. Can I review or change the details of your application after submission and/or settling the payment?

If you want to review or change the details of your firm, you may login the Law Society's Directory of Hong Kong Law Firms 2026 online application system (<http://lawdirectory.hklawsoc.org.hk/en/Apply-for-the-Directory>) for any updates before the deadline.

Any subsequent request for amendments to the listing will be subject to an administrative charge of HK\$100 per amendment.

4. Can I change the law firm address/ add Chinese address?

The pre-filled address is sourced from the on-line law list. If you need to make any amendment to the address, please send your request to regist@hklawsoc.org.hk. Please allow sufficient time for our Registration Department to amend the address. Only updates made before the application deadline will be reflected on the hardcopies of the Directory.

If you wish to change the address/ add Chinese address displayed in the Directory without altering the law list, please send your request to directory@hklawsoc.org.hk. Please note that such changes will only be reflected in the hardcopies of the Directory.

PAYMENT

5. Can I submit my online application and settle payment by cheque?

You can settle payment by credit card (Visa/Master/Union Pay) through the online payment system of The Law Society. Alternatively, you can input the cheque details on the payment system and send a crossed cheque made payable to:

6. Can I submit paper application and settle payment through the online payment gateway?

You can only submit a paper application if you include the cheque with it. Payments through the online payment gateway are not allowed for paper applications. The application form will be provided upon request.

7. Can I submit the online application first and settle the payment later?

Yes, you can enter the application system and repeat steps 1-6 to proceed to the payment page after viewing your application details. Alternatively, you may access the payment page by clicking “Outstanding Payment” on the tab at the top right part of The Law Society webpage after entering the Members’ Zone with your law firm account.



8. Will The Law Society receive my credit card information when I enter it for payment via the System?

The Law Society will not receive any credit card information. All payments are handled directly by the payment gateway service provider.

9. My browser does not respond during the payment process. What shall I do?

Please close the browser and re-login to the System. Go to Members’ Zone and click the “Outstanding Payment” to check if you have any outstanding payment. Alternatively, you can email us at epayment@hklawsoc.org.hk for assistance.
