- (iv) the compilation of The Law List which is published for the purpose of facilitating the public and members of the Society in identifying solicitors, foreign lawyers and law firms registered with the Society and in knowing the services they provide.

It is obligatory for you to supply the Society with the data requested in this form. The consequence for you if you fail to supply such data is that the Society will not be able to process your application for registration as a foreign law firm.

The data may be provided to such persons within the Society whose proper business it is to carry out the purposes mentioned above. The data may also be provided to other persons who may help the Society in attaining the purposes above mentioned.

Any data that is provided outside of the Society will be restricted to what is necessary and not excessive to achieve any intended purpose.
