The personal data collected in this Application ("the data") will be used by the Law Society of Hong Kong ("the Society") for the following purposes:

- (i) The processing of this Application for the issuance by the Society of a no-objection letter to the applicant applying to the Immigration Department for a visa/ entry permit in Hong Kong and related matters;
- (ii) The exercise of the powers of the Society conferred upon it under the Legal Practitioners Ordinance (Chapter 159) and its subsidiary legislation; and
- (iii) The performance of the functions of the Society in accordance with its Memorandum and Articles of Association and the attainment of the objects for which the Society is established.

In making this Application, it is obligatory for you to supply the Society with all data requested in this form except as otherwise indicated. The consequence for you if you fail to supply such data is that the Society will not be able to process this Application.

The data may be provided to such persons within the Society whose proper business it is to carry out the purposes mentioned above and related matters. The data may also be provided to other persons who may help the Society in attaining the purposes above mentioned.

Any data that is provided to anyone outside of the Society will be restricted to what is necessary and not excessive to achieve any intended purpose.

You have the right to request access to and correction of the data. Any such request should be addressed to the Secretary General, the Law Society of Hong Kong, 3/F, Wing On House, 71 Des Voeux Road Central, Hong Kong.

Note 1:

Principal/Partner of law firms should provide the following information to the Law Society in order to demonstrate that the proposed training enables the applicant to acquire special skills and knowledge not available in his/her country/territory of domicile:

- (a) Details of the post offered (including areas of training and job duties of the post, if any).
- (b) The period of training.
- (c) Whether the post offered is an existing position or a new position.
 - (i) If the post offered is an existing position, the current qualification requirements and salaries/benefits for the post.
 - (ii) If the post offered is a new position, the qualification requirements and salaries/benefits for the post.
- (d) Whether the law firm is well established and has the requisite training infrastructure to provide the proposed training to the applicant.
- (e) Justification for the applicant coming to Hong Kong for the training including how the special skills and knowledge acquired from the post can benefit the applicant *vis a vis* the applicant's professional background.
