Welcome Message from the President of the Law Society and Chairman of Pro Bono and Community Work Recognition Programme



In 2010, the Law Society launched the Pro Bono and Community Work Recognition Programme to encourage members to serve the community and motivate them to build a harmonious and caring society with a collaborative spirit.

Over the past twelve years, the Programme has recorded the continued devotion of our profession in serving the community. Over 240,000 hours of pro bono and community work performed by over 1,500 lawyers and 230 law firms have been recorded since the Programme's debut. We also evidenced the continued rise in the numbers of lawyers and law firms involved in pro bono work and community service.

To meet our members' passion to serve the community, the Law Society initiated many pro bono and community programmes and activities for lawyers to participate in, such as the "Free Legal Helpline" which offers 45 minutes of free legal consultation to the public, "Law Week" that aims to enhance the public understanding of law and "Legal Pioneer Mentorship Programme" to further nurture our next generation. The Law Society's "Teen Talk" programme provides a platform for students to gain insights about the rule of law and at its 10th Anniversary in 2021, the students had the unforgettable experiences visiting disciplined services departments across Hong Kong. The Law Society also collaborated with government bureaux / departments, NGOs and charitable organisations to provide free legal advice under Home Affairs Department's "Free Legal Advice Service on Building Management" and the Pilot Scheme on "Free Outreach Legal Advice Service on Building Management", give talks under Hong Kong Council of Social Service's "Social Enterprise Legal Seminar Series" and "NGOs Governance Platform Project", organise visits for students under the Education Bureau's "Business-School Partnership Programme" and community services for under-resourced children with Tung Wah Group of Hospitals.

Together with a large team of enthusiastic volunteer solicitors, the Law Society's pro bono and community service has benefited people from diverse backgrounds, such as children, students, elderly people, and the ones who are deprived of legal advice due to the lack of means. Starting from 2021, the Programme introduced the "Special Award for the Year" dedicating to a different service target each year to further arouse lawyers' and law firms' attention to different groups of people in need.

I cannot be proud enough to witness the dedication of our profession in serving the community. The Law Society will keep working hard to advocate and support a strong pro bono culture throughout the legal profession. I strongly encourage lawyers and law firms to continue their efforts in serving the community in the coming years.





To enhance the general public's understanding of law and encourage solicitors to contribute to the community by serving the general public, the Law Society launched the "Free Legal Helpline" 8200 8002 since 20 May 2013. The Helpline is available from 9:00 a.m. to 5:30 p.m. (From Monday to Friday, except public holidays). This Helpline offers legal advice to the public on five areas of law namely (1) Personal Injuries, (2) Matrimonial Law, (3) Criminal Law, (4) Employment Law, and (5) Wills & Probate. The Helpline is well received by the public and the Law Society has received over 9,000 calls.

Conditions of use of the Free Legal Helpline

Panel of Personal Injuries

The Panel of solicitors will provide up to 45 minutes of free consultation to victims of the incident who want to seek legal advice in their claims for compensation. Victims or a relative (who must be aged 18 or over) on behalf of the victim can make enquiries by calling 8200 8002 and providing the following information to the operator:

- You are making enquiries on Personal Injuries
- Full name of the victim of the incident and the caller
- The alphabet and first four digits of identity card number of the victim of the incident*
- · Telephone number of the victim of the incident or caller
- Date of incident
- Full name of the potential defendant (if known)

A potential defendant / defendant is not eligible under this scheme.

Panel of Matrimonial Law

The Panel of solicitors will provide up to 45 minutes of free consultation on legal issues relating to matrimonial matters. Callers can make enquiries by calling 8200 8002 and providing the following information to the operator:

- You are making enquiries on Matrimonial Law
- Full name of the caller
- Full name of the caller's spouse
- The alphabet and first four digits of identity card number of the caller*
- Telephone number of the caller

Panel of Criminal Law

The Panel of solicitors will provide up to 45 minutes of free consultation on legal issues relating to criminal law matters. Callers can make enquiries by calling 8200 8002 and providing the following information to the operator:

- · You are making enquiries on Criminal Law
- Full name of the caller
- The alphabet and first four digits of identity card number of the caller*
- Telephone number of the caller

Panel of Employment Law

The Panel of solicitors will provide up to 45 minutes of free consultation on legal issues relating to employment law matters. Callers can make enquiries by calling 8200 8002 and providing the following information to the operator:

- Full name of the employee and employer
- The alphabet and first four digits of identity card number of the caller*
- · Telephone number of the caller

Panel of Wills & Probate

The Panel of solicitors will provide up to 45 minutes of free consultation on legal issues relating to wills and probate matters. The Helpline will only handle enquires which the total value of estate not exceeding HK\$10 million for each individual case. Callers can make enquiries by calling 8200 8002 and providing the following information to the operator:

- · You are making enquiries on Wills & Probate
- Full name of the caller
- The alphabet and first four digits of identity card number of the caller*
- · Telephone number of the caller
- Value and nature of the estate (including where the estate is situated)
- Presence of a will
- Date of death and domicile of the deceased (for callers who make enquiries on inheriting an estate)

A panel solicitor will contact you within 3 working days of your call to the Helpline and will provide up to 45 minutes of free advice in relation to your legal issue.

Panel of Mediation

Mediation is voluntary dispute resolution process in which a neutral person, the mediator, helps the parties to reach their negotiated settlement. To continue with our efforts to serve the needs of the society, the Law Society's pilot scheme on mediation has been extended. Up to 45 minutes free telephone session on mediation will be provided. Callers can make enquiries by calling 8200 8002 and providing the following information to the operator:

- · You are requesting information on Mediation
- Full name of the caller
- The alphabet and first four digits of identity card number of the caller*
- · Nature of dispute in question
- Full name of the potential opposing party (if known)

Our Dispute Resolution Coordinator or a panel Solicitor-Mediator will contact you within 3 working days of your call to the Helpline and will provide up to 45 minutes of free session.

Remarks:

- 1. *Collection of personal data including full name, alphabet and first four digits of the ID card number of the caller and/or victim of incident and telephone number is for the purposes of administering the Helpline and the assignment of cases only. The caller and/or victim of incident consents to the Law Society using his or her personal data for the said purposes. All personal data will be deleted within 6 months from the date of call.
- 2. Callers are not eligible under this scheme if they have already obtained legal aid or engaged a lawyer for the matter.
- 3. The Helpline is available from 9:00 a.m. to 5:30 p.m. (From Monday to Friday, except public holidays)
