

### Introduction of "iAM Smart"






"iAM Smart" stands for "internet Access by Mobile in a Smart way".


"iAM Smart" mobile app provides the one-stop personalised digital services platform, which enables users to authenticate their identity using their personal mobile phone as a token.








### "iAM Smart" Sandbox Programme
