The 34<sup>th</sup> edition of the Street Index will be available for sale at the Central Search Office on 19/F, Queensway Government Offices, 66 Queensway, Hong Kong from 2 January 2002. The price is HK\$300.00 per set.

Since the 33<sup>rd</sup> edition, 727 amendments have been made and 14 new streets and 116 new lots/sections/subsections have been added to the Street Index data. In support of a green environment, the User's Guide in paper form will no longer be issued in this edition. Instead, it has been incorporated in the compact disc. ## The Street Index on CD (34th Edition)



#### Introduction

The Index of Streets, House Numbers and Lots in Hong Kong, Kowloon and New Kowloon ("the Street Index") is published by the Land Registry with the primary objective of correlating property addresses with the corresponding lot numbers so as to facilitate land searches in Urban area.

The first 25 editions of the Street Index were published on various dates commencing in the nineteenth century, the 26<sup>th</sup> in 1956, the 27<sup>th</sup> in 1961, the 28<sup>th</sup> in 1967, the 29<sup>th</sup> in 1977 and the 30<sup>th</sup> in 1987. The editions prior to the 28<sup>th</sup> edition consisted of bound volumes – single volume pre-war, double volumes postwar. From the 28<sup>th</sup> edition onwards, the Street Index was published in loose-leaf form, affording a convenient means of making successive additions and alterations. Particulars of additions and alterations were published periodically in "noters-up".

From the 31st edition onwards we replaced the traditional Street Index data in two bulky volumes with a single compact disc, thus enabling users to search the data more speedily and conveniently. The Street Index will continue to be updated and the updated version will be produced annually.

#### Updating of the Street Index

Since the  $33^{\rm rd}$  edition, 727 amendments have been made and 14 new streets and 116 new lots/sections/subsections have been added to the Street Index data.

The present edition shows the position as at 31 August 2001, according to data supplied by the Rating and Valuation Department and information available in the Land Registry up to that date. New data from September 2001 onwards will be published in the next edition.

While every care has been taken to ensure accuracy, the Registry will accept no responsibility for any errors or omissions. If any errors or omissions are discovered, please report them to our Customer Service Manager or to the Street Index Unit.

#### TERMS AND CONDITIONS

- The Purchaser requests for and the Land Registry agrees to provide the Index of Streets, House Numbers and Lots in Hong Kong, Kowloon and New Kowloon ("the Street Index") as specified in the Order Form printed overleaf subject to the terms and conditions hereinafter.
- 2. The primary objective of the Street Index is to correlate the address with the lot number so as to facilitate land searches in Urban area.
- 3. The Street Index shall be sold to the Purchaser in the form of compact disc (CD).
- 4. The Purchaser shall be solely responsible for the acquisition of his own computer equipment, software, skills and support in order to have access to the Street Index. The Land Registry shall not be responsible in whatever respect in connection therewith.
- 5. The Street Index shall be delivered in such mode as may from time to time be determined by the Land Registry.
- 6. Upon placing an order for the Street Index on CD, the Purchaser shall make full payment of the purchase money to the Land Registry in advance and such payment shall not be refundable in full or in part.
- 7. (a) The acceptance of an order shall be subject to the final approval and at the absolute discretion of the Land Registry.
  - (b) In the event that an order is not accepted by the Land Registry, any purchase money paid under the order or any part thereof will be refunded to the Purchaser.
- 8. The Land Registry retains the copyright of the Street Index and the Street Index shall not be used by any person other than the Purchaser. The Purchaser shall not rent or lease or resell the Street Index in its original CD form or in any other form.
