The Council has pleasure in submitting its Annual Report together with the audited statement of accounts for the year ended 31 December.

# **Principal Activities**

The principal activities of The Law Society are to act as the professional and regulatory body for solicitors in Hong Kong. The principal activity and other particulars of the subsidiaries are set out in Note 3 and 8 to the accounts.

#### Accounts

The results of The Law Society's operations for the year ended 31 December and the state of The Law Society's affairs at that date are set out in the accounts on pages 90 to 104.

### Membership

At 31 December there were 6,300 members of The Law Society. The total number of Practising Certificates issued was 5,757. There were 698 firms of solicitors and 48 registered foreign law firms.

### **Fixed Assets**

Movements in fixed assets during the year are set out in Note 7 to the accounts.

### **Donations**

Donations by The Law Society during the year amounted to \$6,146,337 (2005: \$4,558,114) which represent donations to The Law Society of Hong Kong Educational Trust Fund.

#### Auditor

KPMG was the auditor of The Law Society in 2006. The auditor retired and, being eligible, offer itself for reappointment. A resolution for the re-appointment of KPMG as auditor is to be proposed at the forthcoming Annual General Meeting.

#### Bankers

The bankers are The Bank of East Asia Limited, The Hongkong and Shanghai Banking Corporation Limited, Standard Chartered Bank Limited and Wing Lung Bank Limited.

#### **CENTENARY WORKING PARTY**

The Working Party has met on a number of occasions to co-ordinate the planning for the various activities to take place in the Centenary Year which begins on 8 April 2007. Amongst the events scheduled are a series of seminars by distinguished overseas speakers, the running of the Law Society Centenary Cup at the Happy Valley Racecourse on 6 June and the Centenary Dinner on 7 June 2007.

The first distinguished speaker will be the Rt. Hon. Sir Konrad Schiemann a former Law Lord who now sits in the Court of Justice of the European Communities. He will present a talk on 14 April 2007 on the way in which the European Court has managed to incorporate the laws of the individual communities to create one legal system. Other speakers from the United States of America and the People's Republic of China are planned for later in the year.

The June events will also be attended by delegates to the 20th Biennial LawAsia Conference which The Law Society is hosting and the associated meeting of Chief Justices which is hosted by the Judiciary.

The main event of the Centenary planned to date is the dinner on 7 June 2007 in the Grand Hall of the Hong Kong Convention and Exhibition Centre. This will be attended by the Chief Executive of the Hong Kong SAR, the Chief Justice, the Secretary for Justice and other distinguished guests from Hong Kong, the Mainland and overseas. It will be an evening of celebration and enjoyment with singer Francis Yip entertaining guests and dancing to a live band.

The Law Society has prepared and will issue a commemorative stamp sheet in April 2007 to mark the 100th anniversary.

The Young Solicitors' Group and the Recreation & Sports Committee all have plans to hold celebratory events during the year.

# **EMPLOYMENT LAW COMMITTEE**

The Committee was established by the Council to advise the Council on employment issues and to make submissions to the Administration on any proposed legislation touching upon employment in Hong Kong. Since then the Committee has drafted and made submissions on a number of such issues.

The Committee has met on several occasions to discuss the proposed amendments to the Employment Ordinance and has made submissions to the Administration and the Legislative Council on the *Employment (Amendment) Bill.* The Committee will attend the Legislative Council Bills Committee consultations on the proposed legislation.

Members met with the Equal Opportunities Commissioner ("EOC") and his staff for a full and frank exchange of views expressing concern at the procedures followed by the EOC and how this created a perceived bias in favour of the complainant which it was difficult for employers to reverse at reasonable cost. A dialogue was opened with the Commission as to the future drafting of guidelines in which it is hoped the Committee and The Law Society will have some input.

The Committee has jointly with the Constitutional Affairs Committee discussed the *Race Discrimination Bill* and will make submissions to the Administration on the legislation.



The Committee will continue to monitor the legislation, practices and procedures relating to employment in Hong Kong and make recommendations in respect thereof to the Council.

### **LEGAL AID COMMITTEE**

During the year the Legal Aid Committee dealt with a number of issues by way of circulation of papers. Members continued to monitor the assignment of both civil and criminal cases by the Legal Aid Department and the Duty Lawyer Service, raising queries and seeking clarification where appropriate. Members have attended meetings of the Legislative Council Panel on the Administration of Justice and Legal Services ("AJLS") to demonstrate The Law Society's stance on adjustments to the calculation of legal aid applicants' means.

It has supported the work of the joint committee seeking to review the Costs in Criminal Cases Rules and has viewed with concern the reluctance by the Administration to expand either the standard Legal Aid Scheme or the Supplementary Legal Aid Scheme ("SLAS"). Members have repeatedly expressed the view that the expansion of either scheme with suitable increases not only in the means test limits but also in the level of contributions payable could result in a scheme that was both financially viable and encompassing considerably more litigants.

The Committee noted favourably the imposition of limitations on the number of civil cases to be assigned to individual practitioners on an annual quota basis and considered the report by the Legal Aid Services Council on the control of costs and monitoring of case progress by the Legal Aid Department.

The Committee will continue its role of monitoring the activities of the Legal Aid Department and Duty Lawyer Service in so far as they affect members of the Law Society and the effective use of public money and will maintain a dialogue with both organizations to enhance mutual understanding and improvements in the Legal Aid Scheme in Hong Kong.

#### **WORKING PARTY ON CEPA**

The Working Party considered and studied the emerging issues affecting the legal profession and the provision of legal services in Hong Kong or elsewhere by solicitors and by foreign lawyers under the WTO, CEPA and other regional free trade agreements or arrangements. On the further liberation measures under CEPA, the Working Party's proposals were approved by the Council. Under CEPA IV, new measures affecting solicitors' practices will be introduced with effect from 1 January 2007. These measures included:

- (a) the removal of the minimum residency requirement for representatives stationed in representative offices of Hong Kong firms in the Mainland;
- (b) the removal of the minimum number of full-time lawyers employed by Mainland firms that operate in association with Hong Kong firms;
- (c) permitting Hong Kong residents who qualified as Mainland lawyers to act as agents in matrimonial and succession cases relating to Hong Kong in the capacity as Mainland lawyers; and
- (d) permitting Hong Kong residents who are qualified to become Mainland lawyers to complete the prescribed one-year internship in the Hong Kong branch office of a Mainland law firm.

On the WTO negotiations on trade in legal services, the Working Party stressed that the regulatory regime under the *Legal Practitioners Ordinance* (Cap. 159) had certainly made the legal services market in Hong Kong one of the

most accessible in the world. The Council maintained its stance that no specific commitments on legal services under GATS ought to be volunteered by the Hong Kong Government.

### **WORKING PARTY ON RECOVERY AGENTS**

The Working Party has played a monitoring role during the year and has been awaiting the outcome of a number of complaints made to the Department of Justice ("DOJ") by solicitors and members of the public. The Department had

not reached any conclusions as to whether the complaints disclosed any criminal offences and in particular those of maintenance and champerty but a decision has been promised early in 2007. A response to enquiries of the Commissioner for Insurance is likewise awaited.

A meeting was held with the Hong Kong Federation of Insurers which had indicated its members' concerns at the activities of recovery agents and in particular, the belief that a number of claims were being settled with inadequate compensation paid to the victims. A programme of public education is planned with emphasis directed towards those attending Casualty Departments of hospitals, the Labour and Social Welfare Departments and other venues where victims are solicited by recovery agents.

The Working Party has continued to keep the AJLS informed of its concerns.

The Working Party will take steps to educate the public who may be misled by offers made to them by recovery agents and will continue to monitor the situation particularly once the various complaints that have been made are adjudicated.
