# Landing Committee on Policy and Resources

The Standing Committee on Policy and Resources is responsible for formulating and supervising policy and administration for The Law Society and exercising management and control of The Law Society's finances. Matters of policy and finance are thus discussed by the Standing Committee and in appropriate cases referred to the Council for decision.

During the year the Standing Committee met 13 times. Major issues considered by the Standing Committee included:

- Consideration of the Law Society's annual budget and monitoring of income, expenditure and investments on a monthly basis.
- Recommendation to the Council and thereafter to the Chief Justice in relation to the annual Practising Certificate and membership fees.
- Review of the senior posts in the Secretariat and appointment of a Deputy Secretary General.
- Approval for creating the post of Assistant Prosecutor.
- Review of the salary and performance of the staff and recommendations to the Council for a salary increment and payment of incentive bonus for outstanding performance.
- Approval of establishing loyalty awards for staff and awarding gold coins to staff who had worked for the Law Society for more than 10 years.
- Appointment of Council members to the Standing Committees and monitoring the attendance at Law Society meetings.
- Arrangement of professional indemnity cover for the Council and committee members in connection with their activities on behalf of the Law Society.
- Approval of the construction of a website www.choosehklawyer.org to assist members of the

- public to find solicitors and law firms which had volunteered to provide an initial free legal consultation not exceeding 45 minutes.
- Approval of the renewal of the agreement for the publication of *Hong Kong Lawyer* with *LexisNexis* for three years.

The membership of the Standing Committee on Policy and Resources comprises the President, three Vice-Presidents, chairmen of the other Standing Committees and senior members of the Council.
