#### MAJOR PROJECTS/EVENTS

Law Week 2012

A Helpline 8200 8002 for solicitors to provide up to 1 hour free legal advice to the general public was the main feature of *Law Week 2012*. The Helpline was set up for creating a platform for two purposes: (i) for solicitors to contribute to the community by volunteering free legal advisory service; and (ii) for generating potential business opportunities for members who had signed up as panellists attending to enquiries received through the Helpline.

The Helpline covered four areas of law, namely: Personal Injury, Family law, legal matters concerning Small and Medium-enterprises and general legal matters. Efforts were made to publicise the Helpline number through advertisements on trams, at bus shelters, MTR stations and trains, as well as sponsored messages on radio and television services. As a result of such efforts, close to 1,400 calls were received during the three-month period of operation from October 2012 to January 2013. More than 100 solicitors have volunteered as panellists for the Helpline.

Whilst in operation in early October, the Helpline service was officially announced at the opening ceremony of the Law Week on 27 October at the Central Plaza, Wanchai. Officiating guests included: The Hon Chief Justice Geoffrey Ma; the Hon Secretary for Justice Rimsky Yuen, SC, JP; Legislative Councilor for the Legal Functional Constituency; Chairman of Legal Aid Services Council; Director of Legal Aid Department and representatives from the two branches of the legal profession Members of the Helpline Panel were also invited to attend the opening ceremony.

Law Week 2012 has created an impact in the community with a well-planned publicity campaign and the launch of the Helpline service. The event also received substantial media coverage. Responses to the Helpline service were so overwhelming that consideration is being given to making two service a permanent one after re-conclusion of the event.

Law Week 2012 could not be a big success without the support of the Council, and all solicitors on the Helpline Panel as well as the contributions and valuable inputs from the Law Week 2012 Organising Committee Members.

#### Teen Talk

Cammie K.Y. LEUNG

For the third consecutive year, *Teen Talk*, the largest discussion platform for secondary school students from Forms 4 to 6 to freely express their views on different legal issues, was staged at the AsiaWorld Expo on 8 December.

Same as last year, *Teen Talk* received funding support from the Committee on the Promotion of Civic Education to cover part of the expenses incurred. This year, a record high of 2,200 students from 77 schools, 220 facilitators comprising solicitors, trainee solicitors and law students participated in the event.

Bearing the theme of "Law, Respect and Tolerance", *Teen Talk* provided a superb platform allowing The Law Society to promote legal knowledge among the young generation and its members to share their legal expertise with the students. Participating students actively engaged in group discussions focusing on the theme which they might come across in their daily lives. The one-day event included a variety of interactive activities, ranging from videos depicting freedom of expression, cyber bullying, police power to mediation role-play and a mock trial.

Throughout the day, students have demonstrated keen interest in the discussion topics and were enthusiastic in expressing their thoughts or participating in the role play and mock trial. School teachers attending the event also spoke highly of the event in that it did not only contribute to the personal growth of the students, but also enriched their legal knowledge and awareness of their obligations as responsible citizens.

Apart from the formal businesses, The Law Society and the Hong Kong Bar Association ("Bar Association") jointly hosted a lunch and a dinner for the visitors facilitating networking among them and members of the two local in less formal settings. The then Hon Secretary for Justice Wong Yan-lung, SC, joined the dinner as a special guest.














#### Council visit to Beijing

#### Media Relations

The Law Society has always maintained an amiable relationship with the press and other media representatives, either by hosting media luncheons, organising meet-the-press sessions, or cooperating with media companies on special projects.

In February, the then President Junius Ho hosted a spring gathering for reporters; and in May when there was a change of leadership in the Council, the newly elected President Dieter Yih, JP and the two Vice Presidents Ambrose Lam and Stephen Hung met with reporters from both the print and electronic media. Luncheons with the editorial teams of SCMP, Sing Tao and the Standard were subsequently arranged to foster relationship with the journalists. The luncheons and briefing sessions allowed The Law Society representatives an opportunity to familiarise with the editorial policy or approach the press or electronic media took in news reporting; as well as promoting Law Society's activities.





In November, The Law Society hosted a press conference announcing the results of the study on the development of Hong Kong's legal profession in the Qianhai area, and its recommendations on how to further its members' interest in developing their practices in Qianhai.





From time to time, the President and members of The Law Society were approached by reporters for comments on issues concerning or relevant to the legal profession including public policies that might have an impact on the rule of law in Hong Kong. While Council Members had experience in dealing with reporters, there was a demand for polishing their skills in handling interviews, whether over telephone or in person more effectively. To meet such need, a media training workshop was organised for Council Members in September. Veteran journalist Mr. Michael Chugani was there to share his expertise through role plays showing how to deal with pushing reporters or programme hosts and techniques in handling difficult questions, whether at one-on-one interviews or at press conferences.









The Law Society also fostered relationship with the media by supporting activities they hosted such as the *Inter-collegiate Debate Competition* organised by Radio-Hong Kong, by sponsoring programmes for broadcast on the electronic media such as a 13-episode radio series titled "*Tips for Doing Business*" for broadcast on Metro's multi-media platform every Friday

evenings from 9 pm to 9:30 pm from 27 January. small and medium enterprise ("SME") operators or owners and members of the general public who intended to develop their business as Hong Kong or in the mainland were the target audience. The 13-episode radio series covered the following topics:

Hong Kong Council of Volunteering ("HKCOV")

Representing The Law Society, the Standing Committee Chairman sits in the HKCOV as a member. The Law Society also supports the *Hong Kong Volunteers Charter*, an initiative of the HKCOV in promoting further development of volunteering in Hong Kong. In response to HKCOV's appeal to promote the Charter, a web banner with a hyperlink to the Charter will be uploaded to The Law Society Homepage. The Charter will also be circulated to general members.

Collaboration with The Hong Kong Federation of Youth Groups ("HKFYG")

During the year, The Law Society has cooperated with the HKFYG Youth Crime Prevention Centre to help at-risk youths to become law-abiding citizens in Hong Kong. Law Society members volunteered in contributing articles for the Youth Law website managed by HKFYG, and appearing in a series of one-minuters covering various legal issues that young people should be aware of. The Law Society also nominated speakers for conducting seminars for HKFYG frontline workers so that the latter would be equipped with the necessary legal knowledge in handling their young clients.





#### Corporate souvenirs

The Standing Committee is also responsible for ordering corporate souvenirs for use by The Law Society on all occasions. During the year under review, a Working Group was formed to review collection of existing corporate souvenirs and to identify suitable types of souvenirs for future use. #### Corporate brochures and video

In May, Past President Michael Lintern-Smith was invited to be a speaker sharing how foreign businessmen intending to develop business in Hong Kong and mainland China may leverage on Hong Kong's competitive edges for China operations using professional advice available in Hong Kong.

#### Smart Book on Law

CRC launched a new initiative in 2012, i.e. production of a Smart Book containing articles published in the Sing Tao "Legal Mailbox" Column covering legal matters that average folks and businesses may encounter, 10,000 Smart Book was published in February and were distributed to students, teachers and principals, members of NGOs at talks or as souvenirs or as gifts at special events. The booklets were also sent to related organisations so that their members may refer to the information cited in the articles in case they come across certain legal issues and need answers. Arrangement was also made to distribute the booklets at exhibitions/trade events organised by the Hong Kong Trade Development Council ("HKTDC") and to visitors from the Mainland and Taiwan.

Apart from spreading legal knowledge, the Smart Book also constitute an effective PR tool in promoting solicitors' practices and The Law Society's effort in educating the public on various aspects of the law. The task of producing the Smart Book was the concerted effort of the CRC Members who were involved in the selection of the articles and proof-reading the copies intended for print. A second edition would follow as stock for the maiden edition is running short.

#### "Path Builders" Mentorship Programme

Launched in 2009, The Law Society's "Path Builders" Mentorship Programme aims to encourage mentees to develop positive thinking and stay away from drugs through regular mentor-mentee gatherings. The programme was in its 4th phase in 2012 and the launching ceremony was held on 14 July at the Caritas Community Hall with the Commissioner for Narcotics as the officiating guest.

This year, 136 mentors (comprising of solicitors and members from professional bodies) and close to 120 mentees from 22 secondary schools in the Yuen Long, Tai Po, North and Shamshuipo District joined the programme. Participating professional bodies include: the Bar Association, Association of Hong Kong Nursing Staff, Hong Kong Institute of Engineers, The Hong Kong Institute of Chartered Secretaries, The Association of Chartered Certified Accountants ("ACCA") Hong Kong, The Hong Kong Association of Banks, Hong Kong Institute of Architects, Hong Kong Medical Association and Hong Kong Institute of Planners.



#### Rebranding exercise

The GCLAC rebranding kicked off at a cocktail reception on 12 July at the Helena May. It was well-attended by the Council and Committee Members, guests from overseas chambers, trade associations, consulate generals, professional bodies and HKSARG as well as representatives from Mainland and Taiwan organisations with offices in Hong Kong.

GCLAC also launched a new "Greater China Desk" webpage on Law Society's Homepage. The webpage contained information on the legal profession in the Greater China region, updates on relevant legislation in the region and business data that would be useful to both lawyers and potential users of legal advisory services provided by solicitors. In the long run, it is hoped that the webpage would constitute an online forum through which firms may be able to promote their services online and attract business enquiries or referrals.

In addition to the above efforts to publicise the new identity of GCLAC, a seminar on "Building Reputation in a Noisy Marketplace" presented by a seasoned public relations and marketing expert was held on 1 June. The seminar provided useful tips to practitioners on the effective means to market themselves or promote their practices online or through other means. Close to 70 members attended the seminar.















Cross Strait Three Regions Young Lawyers Forum

GCLAC co-hosted the 2nd Cross Strait Three Regions Young Lawyers Forum with the Yong Solicitors' Group on 13 October for the 2nd consecutive year. Bearing the theme of "A Global Perspective: Cross Mergers & Acquisition", the Forum attracted more than 150 lawyers from 19 mainland provinces and cities as well as young lawyers from Taiwan and Hong Kong. An impressive line-up of speakers was also presented at the Forum with Solicitors-General of the Department of Justice ("DOJ"), JP as the officiating guest at the main forum, and other prominent speakers from Taiwan, the Mainland and Hong Kong in the main and breakout sessions.

For the first time, a roundtable discussion amongst the chief delegates of all participating bar associations was held on the day before the Forum was held. The Roundtable provided a superb forum for sharing information on the latest development in the legal profession in difference regions particularly issues facing young lawyers in their practice; and discussion on fostering mutual cooperation.

Networking opportunities were also offered at a cocktail reception held on the day before the Forum and the luncheon held on the event day. Highlights of the Forum were subsequently covered in a post-event press supplement in Wen Wei Po.

Hong Kong Legal Services Forum 2012

Under the coordination of GCLAC, The Law Society, as a supporting organisation, participated in the "Hong Kong Legal Services Forum 2012" hosted by the DOJ of the HKSARG in Guangzhou on 13 September. The Forum was staged to promote Hong Kong legal and arbitration services to enterprises in the Mainland and other potential users of such services. Under the theme of "Think Global, Think Hong Kong", the Forum was targeted at those mainland companies in Guangdong Province who intended to "go global" by venturing into the world markets using Hong Kong as the platform. It also offered opportunities for Hong Kong law firms to showcase their services to potential mainland users, particularly those who wish to use Hong Kong as a platform to expand their businesses in the global markets.

The Forum attracted over 600 participants including The Law Society delegation 20 firms have also participated in a business matching session held immediately after the breakout session promoting Hong Kong legal services. Representatives from these firms attended to enquiries from the mainland participants on the spot.







"Smart Hong Kong" Road Show in Hangzhou

Vice Presidents Ambrose Lam and Stephen Hung together with eight Law Society members participated in the "Smart HK — Hangzhou" organised by the HKTDC and supported by the Hangzhou Municipal Government, local trade organisations and The Law Society on 30-31 August. Three Hong Kong firms and The Law Society each took up a promotional counter to introduce Hong Kong legal advisory services to business people based in Hangzhou and other major cities in Zhejiang Province.

Vice President Ambrose Lam spoke at a seminar attended by over 200 mainland businessmen who were interested in the kind of legal services provided by Hong Kong law firms, or who have business interest in Hong Kong and in need of such services. Mr. Lam was also interviewed by Hong Kong press after speaking at the seminar.

Before taking part in the Hangzhou Road Show, the Law Society delegation visited Ningbo on 28–29 August to renew ties with the Ningbo Lawyers Association with whom The Law Society has signed a cooperation agreement back in 2002. The delegation was warmly greeted by the Deputy Head of the local Justice Bureau, the President and officers of the Ningbo Lawyers Association. The two parties also organised a joint seminar featuring speakers from The Law Society introducing the types of legal services that Hong Kong lawyers can offer to business from Ningbo if they wish to expand their business in overseas markets.









#### Business Mission to Chongqing

From 31 October to 2 November, a 12-member delegation of The Law Society was in Chongqing on a mission to explore business opportunities for Hong Kong law firms. The mission was jointly organised by The Law Society, the HKTDC and Chongqing Lawyers Association. Over 200 representatives of Chongqing enterprises attended a seminar titled "Hong Kong Legal Services — Open the Door to International Trade". The participants had shown much interest in the speakers' presentations on topics covering legal aspects of foreign investments by Mainland enterprises; strategies for foreign mergers, acquisitions and financing; resolving commercial disputes by means of arbitration and mediation; the importance of protecting intellectual property rights to foreign investment; strengthening cooperation between Hong Kong lawyers and Chongqing lawyers and promoting foreign investments by Mainland enterprises. Some Chongqing law firms indicated their wishes to establish associations with Hong Kong law firms or setting up offices in Hong Kong.

Throughout the three-day programme, The Law Society delegation also met with members of the Chongqing Lawyers Association, officials of the Chongqing Justice Bureau, and representatives from the Chongqing Institute of Certified Public Accountants, The Industry and Commerce Association of Chongqing City and law firms in Chongqing. The highly successful mission went a long way toward raising awareness among enterprises in Chongqing of the Hong Kong legal service industry and the advantages of making investments in Hong Kong, and also towards creating new opportunities for the Hong Kong legal profession in Chongqing.





Courtesy visit to Taipei and Kaohsiung

A Taiwan Sub-group was formed under GCLAC this year with a mandate to explore the Taiwan markets and to promote Hong Kong legal services to Taiwan companies, especially those who have business interest in mainland China or intend to develop their business in Hong Kong or in mainland China through Hong Kong.

Three members of the Taiwan Sub-group made a courtesy visit to Kaohsiung and Taipei between 25 to 28 November. They met officials from the Mainland Affairs Council of the Executive Yuan, the Ministry of Justice and the Straits Exchange Foundation in Taipei, the Vice Mayor of Kaohsiung, representatives from the New Taipei Importers & Exporters Chamber of Commerce, Kaohsiung Commerce & Trade Development Association, Kaohsiung Chamber of Industry, and the bar associations in Taipei and Kaohsiung. They also made a courtesy call to the Hong Kong Economic, Trade and Cultural Office.

This trip was fruitful in terms of establishing relationship with the parties concerned and preparing The Law Society for a formal visit to Taiwan sometime in 2013. The trip also allowed The Law Society to acquire a better understanding of Taiwan's business and trade policies and regulations, the business and legal needs of Taiwan companies especially when they intend to start up business in Hong Kong and professional exchanges between lawyers from Hong Kong and Taiwan in areas of arbitration and cross border investment projects.

Participation in Mainland events

Throughout the year, GCLAC organised the following activities in the mainland:

- On 1 April, the then President Junius Ho acted as a speaker at the Advanced Training Workshop organised by the Guangzhou Lawyers Association in Chong Hua. Over 50 young lawyers in Guangzhou attended the workshop where Mr. Ho shared facts about young lawyers in Hong Kong and issues likely facing young lawyers in their practice. Jeff Wong, a Trainee Solicitor from Hong Kong accompanied Mr. Ho on this trip.
- From 25 to 28 May, a Law Society delegation comprising GCLAC Members, and a member of the Mainland Interest Group under the GCLAC visited Tianjin for meetings with the Tianjin Justice Bureau, Tianjin Bar Association, Tianjin Certified Public Accountants, Tianjin Enterprise Confederation and Tianjin Chamber of Commerce. They headed for Beijing for participating in the "Mainland — Hong Kong Services Industry Symposium" hosted by the Ministry of Commerce in collaboration with HKTDC.
- On 25 August, Law Society representatives attended the "Guangdong HK Lawyers Exchange Forum" in Nansha where PRC and Hong Kong lawyers discussed the prospects of forming associations between their firms and issues arising from the association.

Professional Services Development Programme for Hong Kong and PRC lawyers

Five lawyers from Hainan seconded to Hong Kong law firms for a period of four weeks under the *Professional Services* Development Programme.

Under the programme, Hong Kong lawyers were also offered secondments in PRC firms. During the period from 23 to 27 April, five Hong Kong lawyers were seconded to law firms in Guangzhou. This was the last of the four batches of Hong Kong lawyers attending secondment programme in the Mainland. Upon completion of their secondment, they shared their experience in *Hong Kong Lawyer*.

Seminars on China-related legal issues

GCLAC had organised seminars covering China law and related legal issues as follows:

- On 13 January, five Hainan lawyers spoke on the latest development in legal practices relating to tourism, litigation, property transactions in Hainan. 66 members of The Law Society attended the lunch seminar.
- On 2 June, three PRC lawyers from Guangzhou and Shenzhen acted as speakers at a seminar sharing practical knowledge on China law practice and transactions involving foreign investment in the Mainland. 88 participants had attended the seminar.

Outbound mission to Germany with Mainland companies

In early May, Vice President Ambrose Lam joined a HKTDC mission to Germany promoting Hong Kong legal services to both the Mainland enterprises who were on the same mission and to German companies in Berlin, Frankfurt and Munich.

#### Study Mission to Myanmar


Myanmar has become the focus of the world as it opens up its economy to attract foreign investments in the country. The Law Society made a maiden trip to Myanmar from 15 to 18 July, The Law Society delegation comprised 15 members led by President Dieter Yih.


The study mission to Myanmar was fruitful in that relationship with government officials and lawyers in the country was fostered, useful information about Myanmar's law reforms, legal infrastructure, judicial system, economic development and areas of business where Hong Kong practitioners may offer their legal expertise were collected.

During their stay in Myanmar, The Law Society delegates met with the Attorney-General of Myanmar, the Director-General of the Supreme Court, the Chairman of the Myanmar Investment Commission of the Republic of the Union of Myanmar, and members of the Myanmar Federation of Chamber of Commerce and Industry. At the meetings, The Law Society delegation was given to understand that Myanmar is opening up its market to the world offering tax and trade concessions in certain trades. Professional exchanges between lawyers were also welcome.

The trip to Myanmar may have been short, but everyone returned home safe and with information that may be useful for their practice.

Prior to the Study Mission, representatives from The Law Society visited the office of the Consulate General of the Union of Myanmar (HKSAR & Macao) and they were greeted by the Consul General. At the meeting, Law Society representatives expressed intention to establish a strictly professional and business relationship with the legal profession in Myanmar.









"Think Global Think Hong Kong" — Tokyo & Osaka, Japan

On 15 and 17 May, HKTDC staged a large-scale road show — "Think Global Think Hong Kong" in Tokyo and Osaka, Japan, respectively promoting Hong Kong's capabilities in helping Japanese companies reaching out to mainland China, Asia and rest of the world. More than 1,600 participants mainly Japanese business leaders, government officials and members of the business communities from Tokyo and Osaka participated in the event.



As a supporting partner to this mega event, a 13-member

Law Society delegation led by the then President Junius Ho attended the event in both the Tokyo and Osaka legs. Speakers from The Law Society, provided practical tips to Japanese business professionals at the thematic sessions. Merits of using the services of Hong Kong law firms in establishing businesses in Hong Kong and in mainland China were also presented at the thematic sessions.

The Law Society also took the opportunity to renew friendship with Japan Federation of Bar Associations. The two professional bodies discussed the proposals for an Internship Programme for young lawyers from Japan and Hong Kong as well as a list of "Support Lawyers from Hong Kong" to help Japanese SMEs who may need legal advisory services from Hong Kong lawyers for doing business in Hong Kong and mainland China.

Through the participation in this event, The Law Society fulfilled its mission of exploring new markets and identifying potential business opportunities for members.









#### HKTDC outbound missions

In May, Vice President Ambrose Lam joined representatives from Guangdong enterprises on a HKTDC mission to Germany promoting Hong Kong legal services to both the Mainland enterprises and to German companies in Berlin, Frankfurt and Munich.

In September, Immediate Past President Junius Ho joined representatives from Zhejiang enterprises on a HKTDC outbound mission to Japan promoting Hong Kong legal services.

#### Memorandum of Understanding signed with Tokyo Bar Association

The Law Society and Tokyo Bar Association signed a Memorandum of Understanding ("MoU") on 20 February in Tokyo where a law seminar jointly organised by the two professional bodies was held in celebration of the signing of the MoU. The MoU signed signifies the start of a long-term friendship between the two professional bodies.

A 9-member Law Society delegation led by the then President Junius Ho attended this law seminar in Tokyo, which was attended by around 70 Japanese lawyers and representatives from local Japanese companies. Topics of the seminars included "Hong Kong as a Base for Investment in China" and "Hong Kong as a Forum for Cross-border Business Dispute and Resolution".

#### Participation in international conferences and meetings

During the year under review, The Law Society has stepped up its involvement in international conferences and meetings by sending delegations to conferences hosted by the International Bar Association, Union Internationale des Avocats, Inter-Pacific Bar Association, LAWASIA, POLA, Commonwealth Lawyers Association, American Bar Association and All China Lawyers Association. The delegations were either led by the President or Vice Presidents.






 On 1 March, Dr. František Korbel, Deputy Minister of the Ministry of Justice of the Czech Republic visited The Law Society.
