Prosecution on Fiat

As you are aware, the Prosecutions Division of the Department of Justice briefs out a number of criminal prosecutions and appeals to solicitors practising in the private sector to meet operational needs. For that purpose, a few Briefing Out Lists are maintained for cases at different court levels, which include:

- (i) Magistrates' Courts ("MC") "B" List (substituting court prosecutors);
- (ii) MC "A" [Special Fiat] List;
- (iii) District Court List; and
- (iv) Court of First Instance List.

The briefing out practice also helps promote a strong and independent legal profession and secure a pool of experienced prosecutors to supplement those within the Prosecutions Division. To this end, we would like to introduce to you the process of (i) inclusion on and (ii) upgrading to our Briefing Out Lists. Your assistance is also sought to promulgate the matter to members of your society.

Inclusion on the Briefing Out Lists

For solicitor with more than five years' admission, he/she should make a written application (see attached form), together with a copy of his/her full practising certificate and curriculum vitae, to us. Applicants should indicate in their applications the Briefing Out List(s) in which they would like to be included. After being considered by the Prosecutions Division Selection Board ("Board"), the applicant will be informed after a decision is made.

The Hong Kong Advocacy Training Council ("HKATC") organises a "Prosecution on Fiat Training Programme" to train counsel/solicitors with at least one year's call/post-qualification experience in the practice, procedure and skills in conducting prosecutions on fiat in the Magistrates' courts. For solicitors with less than five years' post-qualification experience, upon completion of the programme (including satisfactory performance at the mock trials) or other equivalent training course, they may apply to join an assessment to be separately arranged by us to be considered for inclusion on our MC "B" List. Upgrading to the Briefing Out Lists

Existing fiat solicitor may make a written application (see attached form), together with his/her updated curriculum vitae, to us for upgrading. He/she may indicate in the application the Briefing Out List(s) he/she would like to be upgraded to. After reviewing his/her performance in prosecuting on fiat, the applicant will be informed after a decision is made.

We should be most grateful if you can bring the above information to the attention of all members of your society. Interested solicitor should complete the attached application form and send it together with the supporting documents to the following officer for processing:—
