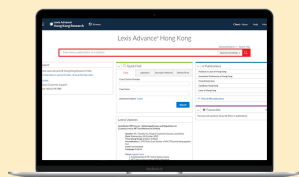
Who is Eligible for a Free Subscription?

The Hong Kong Department of Justice will subsidise eligible professionals in Hong Kong to use the Hong Kong Legal Cloud for **FREE for up to 2 years**. **Eligible subscribers include:**

- **Solicitors** admitted in Hong Kong*
- **Barristers** who have attained the right to full practice in Hong Kong*
- **Mediators** accredited by the HKMAAL
- Fellow or chartered **Arbitrators** of HKI Arb or CI Arb (East Asia Branch)
- **Trainee Solicitors** and **Pupil Barristers** registered in Hong Kong
- **PCLL students** at CityU, CUHK or HKU

* or any one of the recognised jurisdictions as stipulated under section 2A and Schedule 2 of the Legal Officers Ordinance (Cap. 87)
