Home Ownership Scheme Secondary Market Scheme Update documentation

We refer to the Secondary Market Scheme administered by the Hong Kong Housing Authority (HA).

The Housing Authority has introduced the new resale restrictions for Home Ownership Scheme (HOS) flats and Green Form Subsidized Home Ownership Scheme (GSH) flats sold from 2022 onwards. And for King Tai Court, 5 years have elapsed from the date of the first assignment, the specified forms for use within 5 years for King Tai Court are no longer necessary. There are also certain revisions on the current forms. As such, we have revised the whole set of documentation. The details are set out in the Procedural Guidelines with the annexes as attached.

The updated version can be in use with immediate effect. In any event, all members **MUST** adopt the updated version from **1 APRIL 2023** onwards in accordance with the Procedural Guidelines.


