### Street Index (56th Edition)



#### Introduction

The Index of Streets, House Numbers and Lots in Hong Kong, Kowloon and New Kowloon (Street Index) is published by the Land Registry to help users correlate property addresses and building names with lot numbers so as to facilitate land searches for properties in the urban area.

The Street Index was first published in the 19<sup>th</sup> century in bound volume. From the 31<sup>st</sup> edition onwards, it was issued on a single compact disc (CD), enabling users to search the data more speedily and conveniently.

### Updating of the Street Index

The Street Index is updated annually and released for sale as a new edition.

Since the last edition, 402 amendments have been made and 11 new streets and 32 new lots/sections/subsections have been added to the Street Index data.

The 56<sup>th</sup> edition shows the position as at 31 December 2023, according to data supplied by the Rating and Valuation Department and information available in the Land Registry up to that date. New data from 1 January 2024 onwards will be published in the next edition.
