1.1. The firm should have been established for at least 10 years. (Change of firm's name due to acquisition and merger during the last 10 years is permitted subject to support of relevant document).

**2. Accountant's Report**

2.1. The firm should receive clean accountant's report for 3-year period from date of application.

**3. Professional Indemnity**

3.1. Minimum HK\$100,000,000.00
