## PROSECUTION ON FIAT TRAINING PROGRAMME

May - June 2025

This programme is designed to train advocates in the practice, procedure and skills of conducting prosecution on fiat in the Magistrates' courts. It will benefit those who wish to prosecute cases on behalf of the Department of Justice (DoJ). Participants who complete the programme will be given priority to join an assessment separately arranged by the DoJ to be considered for inclusion on the Prosecutions Division Magistrates' Courts 'B' Fiat List.

There are 10 seminars covering pre-trial through post-trial matters with 4 written assignments and a full-day mock trial.

Participants will be partnered up and required to run a full trial based on the brief provided, and will receive feedback on their performance from the Magistrates and trainers.
