Hong Kong Housing Society ("HKHS") New Version of Standard Legal Charge Forms in relation to After Sales Application & Flat-for-Sale Scheme Secondary Market

The HKHS has undergone review of the standard legal charge forms for the mortgage loan for the sale and purchase of the residential units under the Subsidised Sale Flats Project ("SSFP") and Dedicated Rehousing Estates Subsidised Sale Flats Project ("DRE SSFP") completed or to be completed in or after 2024 (hereafter collectively referred as "New SSFP Projects").

Some clauses in the mortgage forms adopted and used by the first-hand purchasers who purchased the residential units in the New SSFP Projects from HKHS and their mortgagee banks have been amended ("the amended First-Hand Mortgage Forms") in accordance with the relevant provisions in the land grants of the New SSFP Projects.

#### Two Versions of Standard Legal Charge Forms

In this regard, HKHS has revised and incorporated similar amendments to formulate a new version (ver. May 2025) of Standard Legal Charge Form (Guarantee) ("Form I-G"), Standard Legal Charge Form (Non-guarantee) ("Form I-NG") and Standard Legal Charge Form (Non-guarantee) (Mortgage Insurance Programme) ("Form MIP") for the subsequent purchasers and their mortgagee banks in the <u>after-sale refinancing and FFSS Secondary Market financing</u> in light of the amendments made to the amended First-Hand Mortgage Forms. Those new forms shall be solely adopted for New SSFP Projects.

Nevertheless, the existing version of Form I-G (ver. Sep 2016), Form I-NG (ver. Sep 2016) and Form MIP (ver. Sep 2018) shall remain applicable to <u>after-sale refinancing</u> and <u>FFSS Secondary Market financing</u> of HKHS's 24 nos. subsidised sale housing projects completed before 2024 (see Schedule I).
