2026 Notaries Public Examination

Hong Kong Society of Notaries (“HKSND”) would like to inform all solicitors of at least 7 years post qualification experience the following:-

1. Part IV of the Legal Practitioners Ordinance (Cap. 159) provides for the framework for examination, appointment and registration of notaries public in Hong Kong.
2. The next notaries public examination is scheduled to be held in the **afternoon of Saturday 25 July 2026 (“2026 Examination”)**.
3. The Guidelines on Application for the 2026 Examination, Appointment and Registration of Notaries Public in Hong Kong have been posted on HKSND’s website at www.notaries.org.hk and are accessible by clicking “*Appointment as Notaries Public*”.
4. **The original applications together with all requisite documents and payment(s) to sit the examination must be delivered by hand to the office of HKSND at the address set out in paragraph 7 below by 5 p.m. Wednesday 12 November 2025 (“deadline”). No fax or electronic applications will be accepted. Incomplete applications or applications without all the requisite accompanying documents and/or payment(s) will not be accepted. No application will be accepted by HKSND after the deadline for whatsoever reason.**
5. A **Training Course** on Notarial Practice and Bills of Exchange will be provided to candidates **at a fee and is optional**. Information on the Training Course is set out in the **attached** sheet as well as posted on HKSND’s website.
6. **Further information** on the 2026 Examination (if any) will be announced through HKSND’s website and, if necessary, also through the Law Society weekly circular in due course.
