INTRODUCTION

The Annual Conference of In-house Lawyers (“Conference”) is the flagship event organised by the In-House Lawyers Committee of The Law Society of Hong Kong. Since its inception in 2011, the Conference has served as a vital platform for in-house legal professionals to discuss and address key issues impacting the industry.

Last year’s Conference saw an impressive turnout, with **over 500 participants** through hybrid participation and was supported by **more than 20 sponsors and partners**. Building on this success, the 2026 Conference is expected to attract a similarly strong and diverse audience.

Themed “**Navigating New Frontiers: In-House Lawyers in a Shifting Global Landscape**”, the Conference will explore the evolving role of in-house legal professionals in an increasingly dynamic global environment this year. The programme will examine emerging challenges and opportunities arising from geopolitical, regulatory, technological and business developments, and facilitate the exchange of practical insights among legal professionals and industry leaders.
