### **Terms & Conditions of Sponsorship**

**Unless otherwise specified, the following terms are applicable to all sponsors (including law firms and companies). All sponsorships are subject to the final approval of The Law Society of Hong Kong ("Law Society"), which has absolute discretion on selecting, accepting and declining sponsors, as well as the final terms of the sponsorship.**

#### **Sponsor materials**

The advertising and sponsor materials are prepared at the sponsors' own expense and must be submitted and approved by the Law Society at least fourteen (14) days prior to the Conference. Law Society will review and share comments to sponsors within five (5) working days.

Sponsors who are scheduled to present at the Conference must submit their presentation slides for approval by the Law Society at least fourteen (14) working days prior to the Conference and Law Society will provide approval within five (5) working days. Sponsors must ensure that all slides comply with the Conference's guidelines and objectives. Any changes requested by the Law Society must be implemented before the final submission.

#### **Terms of payment**

The sponsorship sum is to be paid by cheque or bank transfer (any charges incurred should not be included in the bank transfer amount) within two weeks upon receipt of invoice. The cheque shall be made payable to The Law Society of Hong Kong. The organiser reserves the right to release the reservation and without further notice to the company in question, should the full amount of the invoice have not been booked into the organiser's account by the due date. Any objection or complaint in connection with the invoice must be submitted to the organiser in writing within eight (8) days of the date of the invoice.



### **Early bird payment**

An early bird discount of 10% may be offered to sponsors who return the completed application form to [inhouselawyers@hklawsoc.org.hk](mailto:inhouselawyers@hklawsoc.org.hk) by Thursday, 23 July 2026. To qualify for the early bird discount, the sponsor must ensure that payment is received by the organiser on or before the specified deadline. If payment is not received by this date, the discount terms are deemed not to

have been met, and the discount will be withdrawn. The organiser reserves the right to adjust or withdraw this offer at any time.

### **Speaking opportunities**

Sponsor shall nominate a speaker, subject to organiser's approval. The organiser reserves the right to reject a proposed speaker if, in organiser's reasonable opinion, the speaker is not suitable for the Conference, or the proposed topic does not align with the Conference objectives.

The Sponsor shall submit a presentation title and a brief summary or blurb (no more than 200 words) of the proposed presentation, and speaker's biography and high-resolution photo to the organiser for review. The organiser reserves the right to reject a proposed title and blurb if, in the organiser's reasonable opinion, they do not align with the Conference's objectives or are not suitable for the audience. The Sponsor shall ensure that the submitted title and blurb accurately reflect the content of the presentation and comply with any guidelines provided by the Law Society.

### **Sponsors with booths**

For selected sponsorship packages, a dedicated booth(s) will be provided during the Conference. The booth will be equipped with basic equipment as listed in the sponsorship packages (the "Basic Setup"). Any additional equipment or services beyond the Basic Setup can be arranged with the venue through the Law Society but at the cost of the sponsor.

Booth assignments will be made on a first-come, first-served basis, upon receipt of the signed Contract and payment. Assignments will not be made until payment is received.

Sponsors shall maintain the booth(s) in good order throughout the event. Any damage caused to the booth or its contents by the sponsor or their representatives will be the sole responsibility of the sponsor. The Law Society shall not be held liable for any associated repair cost, loss or damages, and shall be indemnified and held harmless from any claims or liabilities arising from the participation of the sponsors or their representatives in the Conference.



### **Cancellation of sponsorship**

The organiser reserves the right to cancel any agreed sponsorship if any one of the following occurs:

- The sponsor fails to comply with the relevant payment obligations.
- Bankruptcy proceedings, out-of-court settlement proceedings and/or winding up proceedings against the sponsor is/are being carried out or are imminent; and/or
- The sponsorship is not or no longer in keeping with the theme of the Conference.

No refund will be given under any circumstances save for the cancellation of the Conference by the organiser.

### **Event Cancellation, Force Majeure, Cogent Reasons**

If the event cannot be held as a result of force majeure, strikes, political events, fire, flood, typhoon, inclement weather or other cogent reasons, the sponsor shall not be entitled to raise any claims for damages of whatever kind against the organiser. Should the event be cancelled for other reasons, the sponsor agrees to waive any claims towards the organiser for loss of profits. In the event of cancellation by the organiser, all sponsorship payments will be fully refunded subject to deduction of any credit card or bank fees that the sponsorship may incur. All sponsorships are subject to final approval of The Law Society of Hong Kong which has absolute discretion on the selection of sponsors and the final terms of sponsorship.
