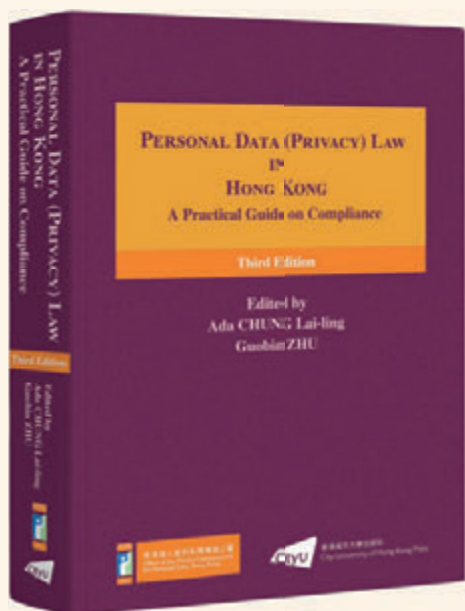

### The Hon LEE Ka-chiu John GBM SBS PDSM PMSM

Chief Executive  
Hong Kong Special Administrative Region of the People's Republic of China

Mr John Lee joined the Hong Kong Police Force in 1977 as a Probationary Inspector of Police and was promoted to Deputy Commissioner of Police in 2010. He served in a variety of posts in the Force, including Assistant Commissioner (Crime), Director of Crime and Security and Deputy Commissioner (Management). He holds a Master's degree of Public Policy and Administration from Charles Sturt University in Australia. Mr Lee was appointed Under Secretary for Security in 2012 and Secretary for Security in 2017. During his service in the Security Bureau, he was responsible for the formulation of security policies covering law and order, immigration and customs control, fire and emergency rescue services, correctional services, government flying services and other areas. He also oversaw and coordinated the work of six disciplined services departments and two auxiliary forces under the Bureau. Mr Lee was appointed Chief Secretary for Administration in 2021. Apart from assisting the Chief Executive in policy administration, Mr Lee was also responsible for supervising the work of nine policy bureaux, harmonising the work which straddled across different bureaux and departments, as well as promoting a good relationship between the Executive Authorities and the Legislature. Mr Lee won the Chief Executive Election of the Hong Kong Special Administrative Region on 8 May 2022 and was appointed as the sixth-term Chief Executive by the Central People's Government on 20 May 2022. Mr Lee assumed office on 1 July 2022.



### CUI Jianchun

Commissioner  
Office of the Commissioner of the Ministry of Foreign Affairs of the People's Republic of China in the Hong Kong Special Administrative Region

Cui Jianchun, graduated with a Master's Degree of Business Administration, is currently the Commissioner of the Ministry of Foreign Affairs of the People's Republic of China in the Hong Kong Special Administrative Region. He served as the Chinese ambassador to Nigeria, the Chinese ambassador to Guyana, the Chinese ambassador to Kuwait, the Minister of the Embassy of China in France, and the Deputy Director General of the Department of Consular Affairs of the Ministry of Foreign Affairs of the People's Republic of China. Besides, he has taken the post of the Director General of the International Cooperation and Development Department in the China National Nuclear Corporation (CNNC), the General Manager of the CNNC Finance Company Limited, the Deputy Director General of the Finance and Accounting Department of CNNC, the Deputy Director General of the Finance and Auditing Department of CNNC, and the Deputy Director General of the Capital Operation Department of CNNC, etc.

Mr Miguel de Serpa Soares served as Under-Secretary General for Legal Affairs and United Nations Legal Counsel from 2013 to 2024. Prior to his UN career, he was Director-General for Legal Affairs in the Ministry of Foreign Affairs of Portugal (between 2008 and 2024) and Legal Counsel of the Permanent Representation of Portugal to the European Union in Brussels (between 1999 and 2008). He has represented his country and the United Nations at multiple legal and governance international fora. He has published and lectured extensively worldwide on different topics of international law. He was admitted to the Bar in 1992 and is a member of several legal societies. He currently lives between Brussels and Lisbon and works as an independent international consultant.

Professor Teresa Cheng is a Senior Counsel, Chartered Engineer, Chartered Arbitrator and Mediator, with a distinguished record of public service in the Hong Kong SAR. From January 2018 to June 2022, Professor Cheng was the Secretary for Justice of the Hong Kong SAR. She specialises in a wide range of legal areas, including construction, international commercial contracts and investment arbitration, and is an experienced practitioner in international arbitration and mediation. She is frequently engaged as counsel or arbitrator in complex international commercial/investment disputes. She is one of the Founder Members of the Asian Academy of International Law, Past Vice President of the International Council of Commercial Arbitration, Past Vice President of the ICC International Court of Arbitration, and Past Chairperson of Hong Kong International Arbitration Centre. In 2008, she became the first Asian woman elected through a global election as President of the Chartered Institute of Arbitrators.
