25-480 (COM) PANEL OF INTERVENTION AGENTS

Intervention into Practice Pursuant to Section 26A LPO

- 1. The Council invites solicitors' firms to apply to the Panel of Intervention Agents ("Panel") established to undertake instructions from the Law Society to intervene into practices in accordance with section 26A of the Legal Practitioners Ordinance. The Council will select a firm from the Panel whenever an intervention occurs.
 - (a) The intervention agent will agree with the Law Society Monitoring Committee the terms for remuneration of the work done by the intervention agent based either on a fixed sum or the fixed rates applicable for remuneration of intervention agents and their staff members as set out in paragraph 3 below subject to the capped fee set out in paragraph 1 (c) below.
 - (b) During the first 8 calendar days following the Council's resolution to intervene ("the 8 days") the intervention agent will take all necessary steps expeditiously including, in so far as is possible, handling clients' or third parties' enquiries, returning files to clients who have requested their return, forwarding on clients' instructions of their files to other firms of solicitors, reviewing and indexing of files for the purpose of the intervention and disposal of files, notifying and requesting banks for bank account balances and bank statements and commencing court applications on behalf of the Law Society to enforce the Council's resolution, if necessary.
 - (c) Subject to exceptional circumstances, the Law Society will pay a fee capped at \$150,000 in respect of the work undertaken during the 8 days.
- 2. The intervention agent will submit to the Law Society Monitoring Committee reports on the intervention and interim bills at regular intervals. The Council reserves the right to tax the bills of the intervention agent.

3. The hourly rates of remuneration for intervention agents and their staff are as follows:

- 4. The Panel will consist of solicitors' firms, but upon instructions to act as intervention agents, the firm will be required to nominate a partner in the firm who will be responsible for the intervention and act as co-signatory of the intervened firm's bank accounts.
- 5. The Council has delegated to the Standing Committee on Compliance to consider the applications. The appointments to the Panel will be made by the Council. For this purpose, the conduct and/or disciplinary records of the solicitors and staff members of the applicant-firms will be disclosed to the Standing Committee on Compliance and the Council for them to assess the suitability of the applicant-firms to be on the Panel.
- 6. Firms wishing to apply should write to the Director of Conduct providing particulars of the composition of the firm and its ability to handle a large volume of work, often at short notice, as well as giving details of any areas of specialization in which the firm practises. Applications will close on **13 August 2025**.

Note: The personal data provided in the information submitted under paragraph 6 will be used for approval, appointment and purposes relating to the application. By submitting the information, you understand and agree that the Law Society may provide the personal data provided in the information to the relevant committee members for the aforesaid purposes.

The professional indemnity cover for all Hong Kong law firms for the 2024/2025 indemnity year will expire on Tuesday, 30 September 2025.

1. Renewal Forms

To renew indemnity, principals of law firms are required to submit an AI and a GFIR (except for new law firms, see paragraph 2(f) below) online via the PIS Digital Platform ("Platform") to the Scheme Manager, ESSAR Insurance Services Ltd. ("ESSAR") under rule 8 of the Solicitors (Professional Indemnity) Rules (Cap. 159M) ("Rules").

A notification email has been sent to the designated principal of each law firm from "do-not-reply@riskonnect.com" regarding the renewal of the 2025/2026 indemnity year via the Platform in late June 2025.

All Hong Kong law firms are required to complete and submit the AI and GFIR (as a scanned (black and white) copy attachment to the AI) executed in accordance with paragraph 2(a)(ii) below to ESSAR via the Platform online on or before 15 August 2025 at 5:30 p.m., for the renewal of their indemnity for the 2025/2026 indemnity year, which commences on 1 October 2025. No physical/ hard copy or other forms will be accepted by ESSAR.

2. The procedure for submitting the AI and GFIR (together the "Documents") online

a) Execution of the Documents

- (i) The AI must be signed by a principal of the law firm.
- (ii) The GFIR must:
 - (1) be signed by a Certified Public Accountant (Practising) ("CPA") reporting the gross fee income of the law firm's Practice for the immediately preceding accounting year of not less than twelve (12) months;
 - (2) be issued under the **letterhead of a CPA firm**;
 - (3) specify the CPA's full name and Practising Certificate number (at the signature block of the GFIR);

If this is the law firm's first time submitting a GFIR, the GFIR should cover the gross fee income of the law firm's Practice from its commencement date and for not less than twelve (12) months.

If the law firm has changed its accounting year end, the GFIR should cover the period from the law firm's last reported accounting year end to the immediately preceding new accounting year end.

The Hong Kong Institute of Certified Public Accountants informed its members through its Circular in May 2022 to utilize the updated GFIR for the purpose of rule 8 of the Rules. The sample wording of the GFIR will be available for downloading when a law firm accesses its AI online.

b) Date of Submission: After 31 July 2025 and on or before 15 August 2025

- The AI requires a law firm to state the name(s) of the solicitor(s) and foreign lawyer(s) practising under the law firm's name as at 31 July 2025. This is because under paragraph 2(1)(a) of Schedule 1 to the Rules, with the exception of new law firms, ESSAR will calculate the amount of annual contribution based on the number of solicitors and foreign lawyers on that date. To ensure that accurate information will be provided to ESSAR, law firms should submit the AI online after 31 July 2025 and on or before 15 August 2025.
- (ii) If law firms choose to submit the AI online before 31 July 2025, it is important that ESSAR be notified of any change in the composition of solicitors and foreign lawyers in the law firm between the date of online submission of the AI and 31 July 2025.
- (iii) Under rule 8(1) of the Rules, the last day to submit the Documents is Friday, 15 August 2025.

c) Failure to submit the Documents by the statutory deadline of 15 August 2025

Failure to comply with rule 8 is a breach of the Rules. Any failure shall be considered by the Working Party on PIS Gross Fee Income Reports and Contributions ("Working Party") with recommendations to the Council to take appropriate action.

d) Documents are to be submitted ONLINE ONLY via the Platform

Do NOT send physical or hard copies of the Documents to ESSAR or the Law Society.

e) Application for an Extension of Time: To be sent to The Law Society

If for any reason a law firm is not able to meet the statutory deadline of 15 August 2025, the law firm should make a <u>PRIOR</u> application to the Council for an extension of time to submit the Documents, setting out (i) the period of time extension required and (ii) the reasons for requiring it. All applications should be addressed to the Assistant Director, Professional Indemnity Scheme, at the Law Society, 3/F, Wing On House, 71 Des Voeux Road Central, Hong Kong. Applications should be made on or before 8 August 2025 as there is no guarantee that applications received after this date can be considered by the Working Party before the statutory deadline of 15 August 2025.

f) New Law Firms or Law Firms without the first set of Audited Accounts

A new law firm, i.e. a law firm which commenced practice after 15 August 2024 or a law firm which has not had its first set of accounts audited, will not need to submit a GFIR by 15 August 2025. It must, however, submit an AI online via the Platform by 15 August 2025 to comply with rule 8(1) of the Rules. The new law firm will not need to state the amount of gross fee income in the AI. Pursuant to paragraph 2(2) of Schedule 1 to the Rules, the new law firm will pay a basic average contribution for the PIS renewal for the 2025/2026 indemnity year.

g) Law Firms intending to Cease Practice

Any law firm which intends to cease Practice prior to the commencement of the 2025/2026 indemnity year must comply with Practice Direction D7 of the Law Society Practice Directions. In particular, for the purpose of professional indemnity cover, the law firm must give notice of cessation to ESSAR at least 8 weeks prior to 30 September 2025. If the notice period ends on a date after 30 September 2025, the law firm may be required to pay contribution for the whole of the 2025/2026 indemnity year subject to any adjustment to be made upon cessation of Practice.

3. An email regarding the PIS renewal 2025/2026 will be sent to the designated email address of the designated principal of each law firm in early July 2025 by the Law Society. Members are reminded to take note that the email will be sent from "adpis_group@hklawsoc.org.hk".

Recruitment of Solicitor Volunteers

- 1. In collaboration with the Home Affairs Department ("HAD"), the Law Society launched the Free Legal Advice Service on Building Management ("the Service") in January 2015. The Law Society is now looking for more volunteers to participate in the Service.
- 2. The Service is limited to cases involving building management. HAD's 18 District Offices receive applications from Owners' Corporations (OCs), Owners' committees, Mutual Aid Committees, members of management committees/executive committees of owners/residents organisations, owners, tenants/occupiers. Each applicant is allowed to receive the service once.
- 3. The eligible cases will be assigned to solicitor volunteers and the completed application form, together with relevant documents, if any, will be sent to the solicitor volunteer assigned at least 5 working days before the scheduled appointment. Interviews will take place at the venues below:

- 4. On the appointed date, the solicitor volunteer will give verbal advice to the applicant during the interview and put down a brief note of the advice given on an interview record form. 
