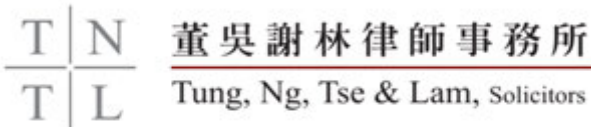

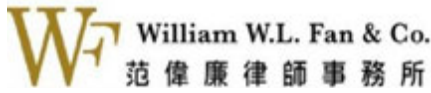

Invitation to “iAM Smart” Webinar for New Features of “iAM Smart”

It is my pleasure to inform you that “iAM Smart” has introduced a number of new features over the past year. We write to cordially invite you to assist in disseminating this email to your member organisations. This email provides information on “iAM Smart” (「智方便」) new features and your member organisations are most welcome to apply for the Sandbox Programme in preparation for adopting “iAM Smart” for their online services.

“iAM Smart”

“iAM Smart” aims to provide all Hong Kong residents aged 11 or above with a single digital identity and an authentication function to conduct government and commercial transactions online. Hong Kong residents are free to register and use the “iAM Smart”. At present, there are more than 3.5 million “iAM Smart” registered users and the number has been on the rise. Over 1200 services of government, public, private organisations and government e-forms are now accessible through “iAM Smart”. Detailed information is available at the “iAM Smart” website (<https://www.iamsmart.gov.hk>).

New Features of “iAM Smart”

Over the past year, “iAM Smart” has introduced a number of new features to enhance user experience, including:

- Simplified “iAM Smart+” registration using Near Field Communication (NFC) on mobile devices.
- “iAM Smart” personal code for a more efficient way for presenting partial personal information during verification and registration processes.
- A redesigned user interface with categorised services for easier navigation and better user experience.
- A “Personal Assistant” Page that enables citizens to access their personal, account, and billing information, as well as payment functions in a convenient and swift manner.
- A Mini-program Platform that allows users to access online services from various organisations directly within “iAM Smart”, without downloading separate mobile applications.
- Step-up Authentication that provides additional identity verification through facial recognition and/ or Hong Kong Identity Card checking for critical and high-value transactions

More detail information about the new features of “iAM Smart” will be introduced in the webinar.

“iAM Smart” Sandbox Programme

To facilitate online service providers to adopt “iAM Smart” for various types of online services, we have been working with Cyberport to operate the Sandbox Programme for public and private organisations to access to integrated testing environment to build proof-of-concepts using “iAM Smart”. Currently, online service providers are free to adopt “iAM Smart” for online services and they can access useful information on the Sandbox Programme website to expedite “iAM Smart” adoption for their online services.
