25-532 (SD) APPOINTMENT OF LEGAL ADVISOR REGARDING THE ARTICLES OF ASSOCIATION OF A SOLICITOR CORPORATION

- 1. A solicitor corporation must be a company formed and registered under the Companies Ordinance (Cap. 622) or under a former Companies Ordinance as defined by Section 2(1) of the Companies Ordinance (Cap. 622). The Law Society invites law firms to submit an expression of interest to prepare the sample objects clause and some sample clauses in the articles of association of a solicitor corporation for compliance with the Solicitor Corporation Rules ("SCR") to be implemented for the incorporation of law firms and to identify the articles in Schedule 2 to the Companies (Model Articles) Notices (Cap. 622H) ("Schedule 2 Model Articles") which must be modified or excluded for compliance with the
- 2. The scope of work of the legal advisor includes :-
 - (i) To prepare sample objects clause and sample clause on the prohibition on exercise of voting rights by a member under Section 16(2) of the SCR that are required to be provided in the articles of association of a solicitor corporation under Section 7(1) of the SCR;
 - (ii) To review the SCR and the related amendments to the Legal Practitioners Ordinance (Cap. 159) ("LPO"), to identify those specific requirements that would be beneficial to be included in the articles of association of a solicitor corporation to ensure their compliance/enforceability even though it is not mandatory under the law to do so, and to prepare sample clauses accordingly;
 - (iii) To identify those model articles contained in Schedule 2 Model Articles that are inconsistent or in conflict with the regulatory requirements on solicitor corporations as set out in the SCR and the related amendments to the LPO, to advise the Law Society on whether Schedule 2 Model Articles should be excluded or modified, and to prepare sample exclusion clause and necessary sample clauses for modifying Schedule 2 Model Articles;

25-533 (SD) APPLICATION BY HONG KONG SOLICITORS FOR SEEKING ADMISSION AS SOLICITORS OF ENGLAND AND WALES

Application for Recognition of Professional Qualifications and/or Experience under the Solicitors Qualifying Examination ("SQE")

- 1. Reference is made to <u>Circular 21-615</u> which announced the granting by the Solicitors Regulation Authority of England and Wales ("SRA") of a pre-agreed exemption from the SQE 2 assessment to Hong Kong solicitors who are qualified through the trainee solicitor route.
- 2. While the said pre-agreed exemption from the SQE 2 assessment still stands, it is noted that individual applications for exemption from the SQE 1 assessment were made to the SRA by Hong Kong solicitors from time to time.
- 3. The evidence required in support of an application for exemption from the SQE 1 assessment is listed on the following webpage of the SRA (including evidence showing, inter alia, that an applicant's qualifications and/or work experience cover the areas of law assessed in SQE 1, and that the law where the applicant is qualified and/or has done his or her work experience is not substantially different to the law of England and Wales):

- 4. As mentioned on the above SRA webpage, if one still wishes to apply for an SQE 1 exemption after reviewing the relevant requirements, one should contact the SRA for guidance via eqsqe@sra.org.uk before making any application.
- 5. As communicated by the SRA to The Law Society of Hong Kong ("Law Society"), Hong Kong solicitors cannot rely on the pre-agreed exemption from the SQE 2 assessment in support of an application for exemption from the SQE 1 assessment.
- 6. To facilitate the Law Society's continuous engagement with the SRA on SQE exemptions, members who have previously made applications for exemption from the SQE 1 assessment are invited to provide (a) their experience (and outcome) of such applications; and (b) guidance provided by the SRA (if any) by email to adrg2@hklawsoc.org.hk.
- 7. Personal data provided by individual members will not be passed to the SRA without the prior consent of the member.

25-537 (PA) PROFESSIONAL INDEMNITY SCHEME ("PIS")

Application for Indemnity Form ("AI") and Gross Fee Income Report ("GFIR") to be submitted online on or before Friday, 15 August 2025 5:30 p.m. (Repeat Circular)

The professional indemnity cover for all Hong Kong law firms for the 2024/2025 indemnity year will expire on Tuesday, 30 September 2025.

1. Renewal Forms

To renew indemnity, principals of law firms are required to submit an AI and a GFIR (except for new law firms, see paragraph 2(f) below) online via the PIS Digital Platform ("Platform") to the Scheme Manager, ESSAR Insurance Services Ltd. ("ESSAR") under rule 8 of the Solicitors (Professional Indemnity) Rules (Cap. 159M) ("Rules").

A notification email has been sent to the designated principal of each law firm from "do-not-reply@riskonnect.com" regarding the renewal of the 2025/2026 indemnity year via the Platform in late June 2025.

All Hong Kong law firms are required to complete and submit the AI and GFIR (as a scanned (black and white) copy attachment to the AI) executed in accordance with paragraph 2(a)(ii) below to ESSAR via the Platform online **on or before 15 August 2025_at 5:30 p.m.**, for the renewal of their indemnity for the 2025/2026 indemnity year, which commences on 1 October 2025. No physical/ hard copy or other forms will be accepted by ESSAR.

2. The procedure for submitting the AI and GFIR (together the "Documents") online

a) Execution of the Documents

- (i) The AI must be signed by a principal of the law firm.
- (ii) The GFIR must:
 - (1) be signed by a Certified Public Accountant (Practising) ("CPA") reporting the gross fee income of the law firm's Practice for the immediately preceding accounting year of not less than twelve (12) months;
 - (2) be issued under the letterhead of a CPA firm;
 - (3) specify the CPA's full name and Practising Certificate number (at the signature block of the GFIR);

If this is the law firm's first time submitting a GFIR, the GFIR should cover the gross fee income of the law firm's Practice from its commencement date and for not less than twelve (12) months.

If the law firm has changed its accounting year end, the GFIR should cover the period from the law firm's last reported accounting year end to the immediately preceding new accounting year end.

The Hong Kong Institute of Certified Public Accountants informed its members through its Circular in May 2022 to utilize the updated GFIR for the purpose of rule 8 of the Rules. The sample wording of the GFIR will be available for downloading when a law firm accesses its AI online.

b) Date of Submission: on or before 15 August 2025

- (i) The AI requires a law firm to state the name(s) of the solicitor(s) and foreign lawyer(s) practising under the law firm's name as at 31 July 2025. This is because under paragraph 2(1)(a) of Schedule 1 to the Rules, with the exception of new law firms, ESSAR will calculate the amount of annual contribution based on the number of solicitors and foreign lawyers on that date.
- (ii) Under rule 8(1) of the Rules, the last day to submit the Documents is Friday, 15 August 2025.
- c) Failure to submit the Documents by the statutory deadline of 15 August 2025

Failure to comply with rule 8 is a breach of the Rules. Any failure shall be considered by the Working Party on PIS Gross Fee Income Reports and Contributions ("Working Party") with recommendations to the Council to take appropriate action.

d) Documents are to be submitted ONLINE ONLY via the Platform

Do NOT send physical or hard copies of the Documents to ESSAR or the Law Society.

e) Application for an Extension of Time: To be sent to The Law Society

If for any reason a law firm is not able to meet the statutory deadline of 15 August 2025, the law firm should make a <u>PRIOR</u> application to the Council for an extension of time to submit the Documents, setting out (i) the period of time extension required and (ii) the reasons for requiring it. All applications should be addressed to the Assistant Director, Professional Indemnity Scheme, at the Law Society, 3/F, Wing On House, 71 Des Voeux Road Central, Hong Kong. Applications should be made on or before 8 August 2025 as there is no guarantee that applications received after this date can be considered by the Working Party before the statutory deadline of 15 August 2025.

f) New Law Firms or Law Firms without the first set of Audited Accounts

A new law firm, i.e. a law firm which commenced practice after 15 August 2024 or a law firm which has not had its first set of accounts audited, will not need to submit a GFIR by 15 August 2025. It must, however, submit an AI online via the Platform by 15 August 2025 to comply with rule 8(1) of the Rules. The new law firm will not need to state the amount of gross fee income in the AI. Pursuant to paragraph 2(2) of Schedule 1 to the Rules, the new law firm will pay a basic average contribution for the PIS renewal for the 2025/2026 indemnity year.

g) Law Firms intending to Cease Practice

Any law firm which intends to cease Practice prior to the commencement of the 2025/2026 indemnity year must comply with Practice Direction D7 of the Law Society Practice Directions. In particular, for the purpose of professional indemnity cover, the law firm must give notice of cessation to ESSAR at least 8 weeks prior to 30 September 2025. If the notice period ends on a date after 30 September 2025, the law firm may be required to pay contribution for the whole of the 2025/2026 indemnity year subject to any adjustment to be made upon cessation of Practice.

3. An email regarding the PIS renewal 2025/2026 has been sent to the designated email address of the designated principal of each law firm in early July 2025 by the Law Society. Members are reminded to take note that the email has been sent from "adpis_group@hklawsoc.org.hk".

25-538 (COM) CLERKS TO THE SOLICITORS DISCIPLINARY TRIBUNAL

(Repeat Circular)

- 1. Firms are invited to assist the Solicitors Disciplinary Tribunal ("the Tribunal") in the performance of its regulatory functions by nominating their qualified or unqualified staff members (the latter, preferably Legal Executives) with over 10 years' working experience in civil or criminal proceedings to join the Panel of Clerks to the Tribunal ("the Panel of Clerks"). The appointees are expected to be mature, possess good communication skills and be able to work independently.
- 2. Firms with solicitors and unqualified staff member who are currently serving as Clerks to the Tribunal are also welcome to nominate those solicitors and/or their unqualified staff member to join the Panel of Clerks.
- 3. The hourly rates for the appointees on the Panel of Clerks is HK\$2,000 for solicitors and HK\$1,000 for unqualified staff members, and are payable to the firms. Payment of the firms' bills may be subject to taxation.
- 4. The duties of the Clerks to the Tribunal include (i) assisting the Tribunal to arrange hearings and associated matters; (ii) performing administrative and clerical duties during the hearing and such other duties as more particularly described in Sections 10(3), 12(2), 12(2A) and 12(9) of the Legal Practitioners Ordinance, Cap.159 and Rules 2, 6(2), 8(1), 9, 13(1), 15, 16, 17 and 34 of the Solicitors Disciplinary Tribunal Proceedings Rules, Cap 159C; and (iii) performing any other secretarial duties as directed, from time to time, by the Chairman of the Tribunal.
- 5. The Tribunal Convenor to the Solicitors Disciplinary Tribunal Panel ("Tribunal Convenor") will conduct the selection process and appoint the Panel of Clerks. Any conduct history and/or disciplinary records of the applicants kept by the Law Society will be disclosed to the Tribunal Convenor for the purpose of processing the applications.
- 6. Interested firms should send the CV(s) of the applicant(s) together with a letter of consent from a sole practitioner/sole proprietor, or a letter of consent from the employer and a letter of consent from the applicant (click here for the requisite terms of the letters) to the Director of Conduct, the Law Society, 3/F, Wing On House, 71 Des Voeux Road Central, Hong Kong on or before 11 September 2025.
