25-634 (PA)LEGAL VISITS AGREED ARRANGEMENT

1. This Circular sets out the agreed arrangements between The Law Society and the various law enforcement agencies on legal visits to detained persons.

- 2. Members are invited to note in particular the agreed arrangements between The Law Society and the Correctional Services Department including the requirements on the letterhead, content, signatory and mode of presentation of an authorisation letter for conducting legal visit. Further, it should be noted that a separate notification letter for each detainee and for each visit is required and only those persons named in the authorization letter are allowed to conduct the legal visit.
- 3. In addition, members are reminded of the following for the purpose of legal visits:-
 - (a) Principals of solicitors' firms should consider whether any family or personal relationship which
 - (i) they, and/or
 - (ii) a member of their staff

may have with a detained client affect them and/or their staff to properly and impartially advise the client. Firms must exercise great caution when they are to send their solicitors, trainee solicitors or authorised solicitors' clerks to visit a client who is known to be a relative or friend of any of them. Any conflicts of interests or possible abuses of arrangements of legal visits arising from the above MUST be avoided. A solicitor must be able to give impartial and frank advice to his client. He must consider whether any family or other personal or emotional relationships which he has may inhibit his ability to advise his client properly and impartially. See Principle 3.01 and the commentary (2) to Principle 7.02 of the Solicitors' Guide to Professional Conduct.

The above applies *mutatis mutandis* to interpreters a solicitors' firm may engage and send for legal visits. Members should try their best to choose and to engage interpreters who are able to render both competent and independent interpretation at legal visits.

- (b) All applications for legal visits will be closely scrutinized by the law enforcement agencies. Amendments to a formal request made by any person, other than the solicitor signing the authorisation letter or the principal(s) of the solicitors' firm, will not be accepted. Refusals for legal visits on such ground, as well as amendments to applications of this nature, will be referred to The Law Society for investigation. Inappropriate applications will be investigated as matters of professional misconduct.
- (c) When trainee solicitor contracts expire, trainee solicitors are not allowed to conduct legal visits, until they are issued with the Practising Certificates, or unless their names are on the current Authorised Solicitors' Clerks List. If they wish to be continually able to conduct legal visits, trainee solicitors should apply to be placed on the Authorised Solicitors' Clerks List well before the expiration of their trainee solicitor contracts.
- (d) Overseas lawyers who do not fall within the exception of Section 50B(2) of the Legal Practitioners Ordinance Cap.159 and who are employed by law firms as paralegals are not allowed to conduct legal visits, unless their names are on the current Authorised Solicitors' Clerks List.
- 4. The Law Society is not in any position to grant any "special permission" for any person to visit clients in places of detention. The authority to permit entry of any person into places of detention is vested in the Correctional Services Department, the Customs and Excise Department, the Immigration Department, the Police and the ICAC, as the case may be.
- 5. For the purpose of this circular, legal visits include ID Parade.
- 6. For video legal visits taking place at the CSD's High Court Cell Holding Unit,
 - (a) Solicitors;
 - (b) Counsel in the presence of representative(s) of law firms

could attend.

- 7. For matters relating to the Authorised Solicitors' Clerks Scheme, see Circular 17-839 (COM).
- 8. Circular 17-838(PA) and the "Arrangement for Legal Visits" referred therein and Circular 24-674(PA) are superseded.

25-635 (COM) ONLINE PLATFORM FOR RENEWAL OF MEMBERSHIP AND PRACTISING CERTIFICATE 2026

- 1. Last year, the Law Society launched an online platform for the renewal of membership and practising certificate. The platform enables members to submit and settle payment of the following applications online:-
 - (a) Renewal of Membership (Solicitor);
 - (b) Renewal of Membership with a Practising Certificate;
 - (c) Statement of Compliance with CPD & RME Form; and/or
 - (d) Recreational and Sports Programme.

Members may also assign their law firms to settle payment for any or all of the online applications electronically.

- 2. The platform has now been enhanced to allow law firms to complete the online application forms for members so that members can verify then submit the applications online.
- 3. The platform with the new feature will be available on or about 29 September 2025. To access the platform and receive application and payment confirmations, members and law firms must have registered their Correspondence Email with the Law Society.
- 4. To facilitate completion of the online application forms, certain fields in the forms will be pre-filled with members' registered information. Members are advised to verify the accuracy of the information before proceeding with online submission.
- 5. Payment for online applications may be made via credit card (VISA, Mastercard or Union Pay) or through the Faster Payment System (FPS). For mass payments, law firms may choose to settle fees either online or by cheque.
- 6. Members remain individually responsible for ensuring the timely submission of applications and settlement of payments.

25-641 (PA) PROFESSIONAL INDEMNITY SCHEME

Payment of Annual Contributions Deadline for Payment: Tuesday, 30 September 2025 (Repeat Circular)

- 1. The professional indemnity cover for member firms for the 2024/2025 indemnity year will expire on Tuesday, 30 September 2025.
- 2. To enable firms to renew their cover for the 2025/2026 indemnity year commencing on 1 October 2025, the Scheme Manager, ESSAR Insurance Services Ltd. ("ESSAR") will be sending out debit notes from late August to early September 2025 to Principals of all firms for the payment of contributions.
- 3. The procedure for effecting payment of the annual contributions
 - (a) **Deadline for Payment**
 - (i) Under paragraph 2(4) of Schedule 1 to the Solicitors (Professional Indemnity) Rules (Cap. 159M) ("Rules"), the contribution must be paid **on or before 30 September 2025**.
 - (ii) Under rule 10 of the Rules, a law firm is only entitled to indemnity (subject to the terms and conditions of cover in the Rules) upon the issue of a receipt and under rule 9, a receipt will be issued only if the contribution is paid.
 - (iii) There is no provision in the Rules by which the Council of the Law Society can extend the deadline of 30 September 2025. It is therefore NOT possible to make an application to the Council to extend the time for payment.
 - (b) Methods of Payment

Payment can be made by (i) cheque payable to 'Hong Kong Solicitors Indemnity Fund Ltd.', (ii) bank transfer or (iii) Faster Payment System ("FPS").

- Please ensure that there are sufficient funds in the bank account of which the cheque is to be drawn from. **Returned cheques will be treated as non-payment** that may result in failure to maintain indemnity under the Rules.
- Please DO NOT send the cheque to the Law Society.
- Payment cannot be effected by credit cards but various financial institutions have offered loans to assist law firms to pay their contributions. Please refer to the Law Society Circular 25-652 (PA) dated 25 September 2025 for details. It may take some time for the financial institutions to process the applications for loans. - 1. From 2019 to 2024, a law course titled "An Introduction to Legal Services and Risk Management for Cross-border Transactions", focusing on legal practice under the common law system, cross-border legal services, and specialised areas of Hong Kong legal practice, was conducted annually for law students at Peking University Law School ("PKU").
- 2. 
