25-674 (COM) ONLINE PLATFORM FOR RENEWAL OF MEMBERSHIP AND PRACTISING CERTIFICATE 2026

Training Videos

- 1. The Law Society's online platform with new feature for renewal of membership and practising certificate was launched on 29 September 2025.
- 2. Following the sharing session held on 9 October 2025, training videos covering the following five types of applications and payment processes will be uploaded to the Members' Zone of the Law Society's website by 10 October 2025. The video will be available under "Membership/Registration Renewal Applications" → "Renewal of Membership with Practising Certificate (Solicitors)":-
 - (a) [For members] How members can handle or verify the applications for Renewal of Membership, Renewal of Membership with Practising Certificate and/or Statement of Compliance with CPD & RME;
 - (b) [For law firm staff] How law firms can complete the application forms for Renewal of Membership with Practising Certificate and Statement of Compliance with CPD & RME for their lawyers;
 - (c) Recreational and Sports Programme;
 - (d) Online payment for individual solicitors; and
 - (e) Online payment for law firms.

25-675 (COM) SOLICITORS: MEMBERSHIP & PRACTISING CERTIFICATES

Applications for 2026 Membership and Practising Certificate (Repeat Circular)

- 1. As part of the Law Society's ongoing efforts to enhance services to members, the Law Society has launched an online platform for solicitors to renew their membership and practising certificates, and to settle payments electronically. For details, please refer to Circulars 25-635(COM) and 25-665 (COM).
- 2. In parallel with the online platform, paper forms for the renewal of 2026 membership and practising certificates are being dispatched to all members by post. Members are not required to contact the Registration Section regarding the delivery of their application forms unless they have not received them by 31 October 2025.
- 3. Paper or online applications for membership and/or for practising certificates effective from 1 January 2026 must be submitted on or before 30 November 2025.
- 4. Members subject to the Practising Certificate (Special Conditions) Rules (Cap.159Y) who have not yet given the six weeks' notice to the Law Society are reminded to submit the Notice of Intention to Apply for a Practising Certificate. Please note that there is no online form for this notice, and blank copies may be downloaded from the Law Society's website. For further details, please refer to Circular 25-502 (COM).
- 5. Pursuant to Rule 3 of the Practising Certificate (Solicitors) Rules (Cap.159L), the application fee for a practising certificate is HK\$6,500. The Council has resolved that the membership subscription fee for 2026 will remain at HK\$2,500. The total fee for applying for a 2026 practising certificate and membership subscription is therefore HK\$9,000.

- 6. Members opting to submit paper applications may settle the payment by cheque, credit card or through the Faster Payment System (FPS) using the individualized QR codes provided. For those choosing to pay by credit card, the completed forms must be submitted at least five working days before the deadline to allow sufficient time for processing.
- 7. Members opting to submit applications online must settle payment electronically via credit card (VISA, Mastercard or Union Pay) or through the Faster Payment System (FPS). Members may assign their law firms to settle payment for any or all of the online applications. To access the online platform and receive application and payment confirmations, members and law firms must have registered their Correspondence Email with the Law Society. Please refer to Circular 25-616 (COM) for details.
- 8. Members are reminded that they remain individually responsible for submitting the relevant applications and ensuring timely payment. Due to the high volume of applications received during this period, the average processing time for membership applications, practising certificate applications and membership cards is approximately four weeks. Applications received by the Law Society after 30 November 2025 may result in (1) practising certificates not being processed before 1 January 2026, and (2) issuance of a 2026 practising certificate valid for less than one calendar year (i.e. from the actual issue date until 31 December 2026). Any case of solicitors practising without a current practising certificate will be referred to the Conduct Section for investigation.
