FFSS Secondary Market Scheme Revision of Documentation

- 1. The Hong Kong Housing Society ("HKHS") has updated its documentation in relation to the FFSS Secondary Market Scheme as follows:
 - (a) There will be two versions of the **Statutory Declaration** in support of the application for a Letter of Nomination ("Statutory Declaration"):
 - the existing version (Ver. Jul 2025) remains applicable to all purchaser(s) other than White Form Secondary Market Scheme ("WSM") 2024;
 - a new version (Ver. Oct 2025) applies only to WSM 2024 purchasers.

These arise from different interpretations of the definition of domestic property ownership, necessitating separate formats to comply with respective government requirements.

- (b) The **Letter of Nomination** issued by HKHS under the FFSS Secondary Market Scheme has also been revised to reflect updated appendix numbering.
