### 25-750 (SG) LEGISLATIVE COUNCIL GENERAL ELECTION

- 1. The 2025 Legislative Council General Election will be held on 7 December 2025.
- 2. A person is entitled to vote at an election to return a LegCo Member for a constituency only if the person is registered as an elector for the constituency (section 48 of the Legislative Council Ordinance ("LCO"), Cap 542).
- 3. Under section 25(1)(a)(vi) of LCO, it is provided that subject to Part 5 of LCO, a person is eligible to be registered as an elector for the Legal Functional Constituency only if the person is a person specified in section 20F of LCO, namely:
  - (a) members of The Law Society of Hong Kong entitled to vote at general meetings of the Society;
  - (b) members of the Hong Kong Bar Association entitled to vote at general meetings of the Association; and
  - (c) legal officers within the meaning of the Legal Officers Ordinance (Cap. 87); and
  - (d) persons appointed under section 3 of the Legal Aid Ordinance (Cap. 91); and
  - (e) persons deemed to be legal officers for the purpose of the Legal Officers Ordinance (Cap. 87) by section 75(3) of the Bankruptcy Ordinance (Cap. 6) or section 3(3) of the Director of Intellectual Property (Establishment) Ordinance (Cap. 412); and
  - (f) the Legal Adviser of the Legislative Council Secretariat and his or her assistants who are in the full-time employment of The Legislative Council Commission and are barristers or solicitors as defined in the Legal Practitioners Ordinance (Cap. 159).

### 25-755 (PA) HIGHER RIGHTS OF AUDIENCE (HRA) APPOINTMENT TO EXAMINING PANELS

Deadline: 30 November 2025

- 1. The Higher Rights Assessment Board ("the Board") appoints Examining Panels for the purpose of conducting assessments of professional competence of applicants for higher rights of audience. For each assessment exercise, there are usually 2 panels, one for civil proceedings and one for criminal proceedings. Pursuant to Rule 17 of the Higher Rights of Audience Rules, each Examining Panel consists of four members. At least one member is selected from a list of not less than six solicitors submitted to the Board by the Council of the Law Society. A member of an Examining Panel holds office for a period of two years.
- 2. There are currently vacancies on the **Examining Panel (Civil)** and the **Examining Panel (Criminal)**. Members who would like to be considered for nomination to the Examining Panels and have a minimum of 10 years of practice experience in civil law and/or in criminal law should send their CVs to the Director of Practitioners Affairs at the Secretariat of the Law Society via email at: <a href="mailto:dpa@hklawsoc.org.hk">dpa@hklawsoc.org.hk</a> marked "HRA Examining Panels" on or before 30 November 2025. Members should specify in their applications which Panel(s) they intend to apply for.
- 3. The Board indicates that if solicitor advocates wish to be considered for nomination to the panels, they should have obtained their higher rights of audience for over 5 years.
- 4. For members' information,
  - The Board usually conducts HRA assessments once a year. Assessments will take place over weekends. The tentative schedule for the coming round of assessments will be as follows:

Criminal written examination 25 April 2026 (Saturday)
Civil written examination: 25 April 2026 (Saturday)
Criminal practical assessment: 9 or 16 May 2026 (Saturday)
Civil practical assessment: 9 and 16 May 2026 (Saturdays)

- 2. In parallel with the online platform, paper forms for the renewal of 2026 membership and practising certificates have been dispatched to all members by post. Members should contact the Registration Section immediately if they have not received the same.
- 3. Paper or online applications for membership and/or for practising certificates effective from 1 January 2026 must be submitted <u>on or before 30 November 2025</u>.
- 4. Members subject to the Practising Certificate (Special Conditions) Rules (Cap.159Y) who have not yet given the six weeks' notice to the Law Society are reminded to submit the Notice of Intention to Apply for a Practising Certificate. Please note that there is no online form for this notice, and blank copies may be downloaded from the Law Society's website. For further details, please refer to Circular 25-502 (COM).
- 5. Pursuant to Rule 3 of the Practising Certificate (Solicitors) Rules (Cap.159L), the application fee for a practising certificate is HK\$6,500. The Council has resolved that the membership subscription fee for 2026 will remain at HK\$2,500. The total fee for applying for a 2026 practising certificate and membership subscription is therefore HK\$9,000.
- 6. Members opting to submit paper applications may settle the payment by cheque, credit card or through the Faster Payment System (FPS) using the individualized QR codes provided. For those choosing to pay by credit card, the completed forms must be submitted at least five working days before the deadline to allow sufficient time for processing.
