3. Any messages left on the Duty Judge's mobile phone may be unattended until some time later. **Members should only use the designated mobile phone in case of urgency after court hours.**
4. Members are advised that there could be last-minute changes to the above roster. On the other hand, the roster may not be made available by the Judiciary to the Law Society for publication in time. Members may wish to make inquiries with the Registrar direct to ascertain the Duty Judge on a particular day.

25-782 (COM) SOLICITORS: MEMBERSHIP & PRACTISING CERTIFICATES

Applications for 2026 Membership and Practising Certificate (Repeat Circular)

1. As part of the Law Society's ongoing efforts to enhance services to members, the Law Society has launched an online platform for solicitors to renew their membership and practising certificates, and to settle payments electronically. For details, please refer to [Circulars 25-635\(COM\)](#).
2. In parallel with the online platform, paper forms for the renewal of 2026 membership and practising certificates have been dispatched to all members by post. Members should contact the Registration Section immediately if they have not received the same.
3. Paper or online applications for membership and/or for practising certificates effective from 1 January 2026 must be submitted **on or before 30 November 2025**.
4. Members subject to the Practising Certificate (Special Conditions) Rules (Cap.159Y) who have not yet given the six weeks' notice to the Law Society are reminded to submit the Notice of Intention to Apply for a Practising Certificate. Please note that there is no online form for this notice, and blank copies may be downloaded from the Law Society's website. For further details, please refer to Circular [25-502 \(COM\)](#).
5. Pursuant to Rule 3 of the Practising Certificate (Solicitors) Rules (Cap.159L), the application fee for a practising certificate is HK\$6,500. The Council has resolved that the membership subscription fee for 2026 will remain at HK\$2,500. The total fee for applying for a 2026 practising certificate and membership subscription is therefore HK\$9,000.
6. Members opting to submit paper applications may settle the payment by cheque, credit card or through the Faster Payment System (FPS) using the individualized QR codes provided. For those choosing to pay by credit card, the completed forms must be submitted at least five working days before the deadline to allow sufficient time for processing.

7. Members opting to submit applications online must settle payment electronically via credit card (VISA, Mastercard or Union Pay) or through the Faster Payment System (FPS). Members may assign their law firms to settle payment for any or all of the online applications. To access the online platform and receive application and payment confirmations, members and law firms must have registered their Correspondence Email with the Law Society. Please refer to Circular [25-616 \(COM\)](#) and [25-674 \(COM\)](#) for details.
8. **Members are reminded that they remain individually responsible for submitting the relevant applications and ensuring timely payment.** Individual members and law firms are reminded to access the member zone of the Law Society's website to check the "Outstanding payment" items and settle the respective payments on or before **30 November 2025**. Due to the high volume of applications received during this period, the average processing time for membership applications, practising certificate applications and membership cards is approximately four weeks. Applications received by the Law Society after 30 November 2025 may result in (1) practising certificates not being processed before 1 January 2026, and (2) issuance of a 2026 practising certificate valid for less than one calendar year (i.e. from the actual issue date until 31 December 2026). Any case of solicitors practising without a current practising certificate will be referred to the Conduct Section for investigation.
