25-795 (SG) HIGHER RIGHTS OF AUDIENCE (HRA)

APPOINTMENT TO EXAMINING PANELS Deadline Extended: 15 December 2025

- 1. The Higher Rights Assessment Board ("the Board") appoints Examining Panels for the purpose of conducting assessments of professional competence of applicants for higher rights of audience. For each assessment exercise, there are usually 2 panels, one for civil proceedings and one for criminal proceedings. Pursuant to Rule 17 of the Higher Rights of Audience Rules, each Examining Panel consists of four members. At least one member is selected from a list of not less than six solicitors submitted to the Board by the Council of the Law Society. A member of an Examining Panel holds office for a period of two years.
- 2. There are currently vacancies on the **Examining Panel (Civil)** and the **Examining Panel (Criminal)**. Members who would like to be considered for nomination to the Examining Panels and have a minimum of 10 years of practice experience in civil law and/or in criminal law should send their CVs to the Director of Practitioners Affairs at the Secretariat of the Law Society via email at: dpa@hklawsoc.org.hk marked "HRA Examining Panels" on or before 15 December 2025. Members should specify in their applications which Panel(s) they intend to apply for.
- 3. The Board indicates that if solicitor advocates wish to be considered for nomination to the panels, they should have obtained their higher rights of audience for over 5 years.
- 4. For members' information,
 - The Board usually conducts HRA assessments once a year. Assessments will take place over weekends. The tentative schedule for the coming round of assessments will be as follows:

Criminal written examination 25 April 2026 (Saturday)
Civil written examination: 25 April 2026 (Saturday)
Criminal practical assessment: 9 or 16 May 2026 (Saturday)
Civil practical assessment: 9 and 16 May 2026 (Saturdays)

• The Board will be able to pay honorariums to Panel members in respect of each formal assessment, that is, for examining the practical demonstrations by the candidates of their skills and advocacy coupled with their knowledge of practice and procedure, marking of the written examination papers of the candidates and preparing a report for the Board. The Board indicates that at this time, a sum of HK\$50,000 per Panel per assessment will be payable.

25-797 (PA) INTELLECTUAL PROPERTY FINANCING SANDBOX UNDER THE CHIEF EXECUTIVE'S 2025 POLICY ADDRESS

- 1. The Intellectual Property Department ("IPD") is appealing on behalf of the HKSAR Government for intellectual property ("IP") legal practitioners' professional support for the IP financing sandbox ("Sandbox") under the Chief Executive's 2025 Policy Address.
- 2. Details provided by the IPD regarding the Sandbox are as follows:
 - (a) The Sandbox is a new policy initiative to be launched through the collaboration amongst the Commerce and Economic Development Bureau, IPD and Hong Kong Monetary Authority ("HKMA"). Its major objective is to promote and develop the local IP financing ecosystem progressively through collaboration and building up rapport amongst various relevant market players including the legal profession. The Sandbox arrangement in essence allows participating banks and enterprises (particularly those in the technology sector) to explore and take part in pilot IP financing transactions (such as credit/debt financing) by leveraging those enterprises' assets covering IPs in a risk-controlled environment, with the support of, amongst others, legal and valuation professions.
 - (b) To facilitate the smooth implementation of the Sandbox, the IPD has been specifically requested to provide to HKMA as early as possible for the banking sector's reference a list of law firms with considerable knowledge and experience in IP practice which are interested to provide the requisite legal support to those participating banks/enterprises in carrying out the pilot IP financing transactions under the Sandbox. At this stage, a list of interested law firms' names will suffice. Supplementary information like detailed descriptions of IP practice knowledge, experience and track records of each interested law firm may be provided later, subject to HKMA's further specific requests.
 - (c) The participating enterprises with IP assets in need of financing may likely comprise small and medium enterprises ("SMEs") if not start-ups. SMEs play a vital role in the market for driving our economic growth but whose overall resources for consulting professional advice and support are often quite limited. Their full participation in the Sandbox at the initial stage is not only a critical factor for enabling the Sandbox to make a good start, but also would eventually contribute to the ultimate success of the

Sandbox in terms of progressively developing and strengthening the ecosystem of IP financing in Hong Kong. It is therefore of utmost importance that those suitable/worthy SMEs will not be precluded from participating in the Sandbox and enjoying the potential business opportunities which the Sandbox can practically offer, simply because they are unable to have access to affordable professional services out of their financial constraint in reality.

- (d) There is no restriction for participants in the Sandbox in terms of IP types or industry/business sectors. Priority may be given to business of the innovation and technology (I&T) sector in alignment with the Government's policy to develop new quality productive forces should the total number of participants exceed the capacity of the participating banks.
- (e) Subject to the preparatory progress, it is anticipated the first cohort of the Sandbox initiative be launched in December 2025 at the earliest. Subject to operational experience, feedback and data to be collected from the first cohort of participants, the Sandbox initiative may involve more cohorts of participants. In the meantime, no definite duration for implementation of the Sandbox initiative is set, given that transactions involving IP financing as a type of financial transactions should be allowed to run their own course in the free market of Hong Kong.
- (f) Accordingly, the IPD shall be grateful to have all participating professional practitioners' considerable and generous support as well as kind understanding by, amongst others, making their best efforts to address/entertain SMEs' special needs and flexibly negotiating with them affordable chargeable professional fees under the Sandbox arrangement. Provision of pro bono professional services by practitioners in appropriate cases will be much appreciated.

(共創明 "Teen" 計劃) (Repeat Circular)

- 1. Under the "Strive and Rise Programme" ("the Programme"), the Government takes the lead to mobilise resources of the community to support underprivileged junior secondary school students so as to broaden their horizons, reinforce their self-confidence, develop a positive outlook on life, set goals for their future and strive for upward mobility, and eventually lift them out of intergenerational poverty.
