Members may wish to notice that where necessary, other specialist committees of the Law Society might also be invited to comment on an issue before (where relevant and appropriate) any responses to members' enquiries can be given. In those cases, further time would be required in the deliberation process.

- 3. If the Property Committee considers that it is appropriate to render views and/or comment on an issue, the issue will be considered and deliberated only upon receipt of all relevant documents and (where applicable) full payment of the requisite application fee before the abovementioned deadline for any scheduled meeting.
- 4. For reference, the Terms of Reference of the Property Committee are as follows:-
  - (1) To promote and advise the profession on good conveyancing practice.
  - (2) To advise the Standing Committee on Standards and Development on means of improving the competence of and supervision of unqualified persons in conveyancing transactions.
  - (3) To determine applications for waiver or modification of the standard forms of Sale and Purchase Agreement.
  - (4) To revise the Guidelines for Deeds of Mutual Covenant and to determine applications for waiver under the Guidelines.
  - (5) To procure settlement and revision of appropriate forms for recommendation to the Council and to procure approval of such forms by the Chief Justice pursuant to Rule 5C of the Solicitors' Practice Rules.
  - (6) To respond to enquiries in relation to the Terms of Reference of the Property Committee PROVIDED THAT the Property Committee will not provide advice on points of law raised by individual members of the profession.
  - (7) To review, consider and comment on bills and legislation affecting or relevant to conveyancing practice, including the Land Titles Ordinance (Cap. 585), its rules and regulations and proposed amendments thereto.
- 5. The Property Committee will *NOT* provide advice on points of law raised by members. It will also *NOT* intervene or provide rulings on disputes between firms in any property-related transaction. Even if views of the Property Committee have been given on a particular matter, such would not be binding upon the parties to the transaction; those views would also not prejudice any investigations for compliance purposes, or any disciplinary proceedings arising therefrom.

The Property Committee from time to time receives search enquiries from members on whether any waiver or consent letters have been issued to other firms in relation to Law Society Practice Direction A5 or Rule 5C of the Solicitors' Practice Rules ("Rule 5C"). Members seeking the above information could submit a search request in writing in respect of applications that the Law Society received from January 1997 onwards, with payment of a non-refundable administrative fee of HK\$3,500. Please note that the Law Society reserves its full right to disclose to other members/firms correspondence concerning applications for waiver or consent under Law Society Practice Direction A5 or Rule 5C.

# 25-808 (COM) STUDENT MEMBERSHIP RENEWAL 2026

- 1. As part of the Law Society's ("LSHK") ongoing efforts to enhance its services to members, LSHK has launched the online platform for student membership renewal at the end of 2024.
- 2. Paper forms are no longer available. Student members who are eligible and wish to renew their membership for 2026 are required to complete the online application by 31 December 2025.
- 3. The Council of LSHK has resolved that no subscription fee will be charged for student membership for 2026.
- 4. To facilitate completion of the application, certain fields in the online form have been prefilled with the student member's information on record with LSHK. Student members are advised to review and verify the pre-filled information carefully.
- 5. Any student member who has enrolled in a new course since their last application must upload one of the following documents to the online platform:
  - (a) a confirmation letter issued by the institution; or
  - (b) a current student card from the institution showing (i) his/her status as a current law student and (ii) the course being attended.
- 6. If the online application is not completed by 31 December 2025 and the current 2025 student membership lapses without renewal, the LSHK email account assigned to the student member (name@member.hklawsoc.org.hk) will be terminated with effect from 1 January 2026. The account will be reactivated upon successful completion of the membership renewal.

# 25-810 (PA) MANDATORY PROVIDENT FUND REVISED GUIDELINES (GUIDELINES I.7)

- 1. The Mandatory Provident Fund Schemes Authority ("Authority") has issued the revised Guidelines on Central Securities Depositories (Guidelines I.7), which came into effect on 9 December 2025.
- 2. According to the Authority, the purpose of the revisions is to reflect the approval of a depository, namely, Viet Nam Securities Depository and Clearing Corporation, by the Authority as a central securities depository for the purposes of the Mandatory Provident Fund Schemes (General) Regulation (Cap. 485A). In addition, some housekeeping changes have been made by the Authority to Guidelines I.7.
- 3. The revised Guidelines I.7 can be downloaded from the Authority's website. Members may also contact Ms Teresa Lee of the Authority on 2292 1286 to obtain hard copies of the revised guidelines.
