# 25-844 (PA) HIGHER RIGHTS OF AUDIENCE (HRA) APPOINTMENT TO EXAMINING PANELS

# Extended Deadline: 9 January 2026 (Repeat circular)

- 1. The Higher Rights Assessment Board ("the Board") appoints Examining Panels for the purpose of conducting assessments of professional competence of applicants for higher rights of audience. For each assessment exercise, there are usually 2 panels, one for civil proceedings and one for criminal proceedings. Pursuant to Rule 17 of the Higher Rights of Audience Rules, each Examining Panel consists of four members. At least one member is selected from a list of not less than six solicitors submitted to the Board by the Council of the Law Society. A member of an Examining Panel holds office for a period of two years.
- 2. There are currently vacancies on the **Examining Panel (Civil)** and the **Examining Panel (Criminal)**. Members who would like to be considered for nomination to the Examining Panels and have a minimum of 10 years of practice experience in civil law and/or in criminal law should send their CVs to the Director of Practitioners Affairs at the Secretariat of the Law Society via email at: <a href="mailto:dpa@hklawsoc.org.hk">dpa@hklawsoc.org.hk</a> marked "HRA Examining Panels" on or before 9 January 2026. Members should specify in their applications which Panel(s) they intend to apply for.
- 3. The Board indicates that if solicitor advocates wish to be considered for nomination to the panels, they should have obtained their higher rights of audience for over 5 years.
- 4. For members' information,
  - The Board usually conducts HRA assessments once a year. Assessments will take place over weekends. The tentative schedule for the coming round of assessments will be as follows:

Criminal written examination 25 April 2026 (Saturday)
Civil written examination: 25 April 2026 (Saturday)
Criminal practical assessment: 9 or 16 May 2026 (Saturday)
Civil practical assessment: 9 and 16 May 2026 (Saturdays)

• The Board will be able to pay honorariums to Panel members in respect of each formal assessment, that is, for examining the practical demonstrations by the candidates of their skills and advocacy coupled with their knowledge of practice and procedure, marking of the written examination papers of the candidates and preparing a report for the Board. The Board indicates that at this time, a sum of HK\$50,000 per Panel per assessment will be payable.

# Waiver of Application Fee for Will Searches — Tai Po Tragic Fire

- 1. To assist bereaved families with estate-related matters, the Council has resolved to grant a waiver of application fee for will searches specified in circular <u>21-478(PA)</u> where it is confirmed that the deceased persons passed away in the Tai Po tragic fire.
- 2. This waiver shall only apply to the following interested parties to the deceased persons:
  - (a) Executor(s);
  - (b) Administrator(s); and
  - (c) Beneficiary(ies).
- 3. To be eligible for this waiver, an application must be accompanied by a written confirmation by the firm as follows: "To the best of our knowledge, information and belief, the person named as the deceased person is a victim of the Tai Po Tragic Fire that broke out on 26 November 2025." Members should refer to this circular in the applications.
- 4. Please refer to circular <u>21-478(PA)</u> for details of Will Search application.
- 5. For will searches on deceased persons passed away in the Tai Po tragic fire, members should note that the completed application form and all relevant documents should be submitted to the Law Society **without** the requisite application fee. Should it be subsequently determined that the application does not qualify for this waiver, firms will be requested to provide the requisite application fee.
- 6. The Law Society reserves the full discretion in deciding whether the will search applications are eligible for this waiver of application fee.

# 25-849 (COM) PANEL OF PROSECUTORS FOR SOLICITORS DISCIPLINARY TRIBUNAL PROCEEDINGS (Repeat Circular)

- 1. Members, preferably partners of a firm, with more than 10 years' post qualification experience are invited to apply for appointment to the Panel of Prosecutors for solicitors disciplinary tribunal proceedings ("Panel of Prosecutors").
- 2. Applicants should have appropriate advocacy skills and relevant experience in criminal and civil cases, particularly prosecution experience.
- 3. The appointment to the Panel of Prosecutors will be made on an individual basis. Appointments will be for renewable periods of two years and successful applicants will be expected to continue acting in assigned cases until their conclusion despite expiry of the term.
- 4. Any conduct history and/or disciplinary records of the applicants will be disclosed to the Standing Committee on Compliance for the purpose of processing the applications.
- 5. Members who wish to be considered for appointment to the Panel of Prosecutors should send their written application together with a resume of their experience to the Director of Conduct on or before 7 January 2026.

The resume should consist of not more than 2 sides of A4 paper giving contact details and particulars of practice experience.

# 25-852 (COM) STUDENT MEMBERSHIP RENEWAL 2026 (Repeat Circular)

- 1. As part of the Law Society's ("LSHK") ongoing efforts to enhance its services to members, LSHK has launched the online platform for student membership renewal at the end of 2024.
- 2. Paper forms are no longer available. Student members who are eligible and wish to renew their membership for 2026 are required to complete the online application by 31 December 2025.
- 3. The Council of LSHK has resolved that no subscription fee will be charged for student membership for 2026.
- 4. To facilitate completion of the application, certain fields in the online form have been prefilled with the student member's information on record with LSHK. Student members are advised to review and verify the pre-filled information carefully.
- 5. Any student member who has enrolled in a new course since their last application must upload one of the following documents to the online platform:
  - (a) a confirmation letter issued by the institution; or
  - (b) a current student card from the institution showing (i) his/her status as a current law student and (ii) the course being attended.
- 6. If the online application is not completed by 31 December 2025 and the current 2025 student membership lapses without renewal, the LSHK email account assigned to the student member (name@member.hklawsoc.org.hk) will be terminated with effect from 1 January 2026. The account will be reactivated upon successful completion of the membership renewal.


