1. In the past, data was finite. However, the advent of the internet has introduced an overwhelming volume of emails, spreadsheets, chats, and diverse data from across the globe. As legal professionals, we are tasked with uncovering the smoking gun, identifying collusion, detecting breaches of personal information, assessing intellectual property ("IP") theft, and understanding risks and exposures within contracts. 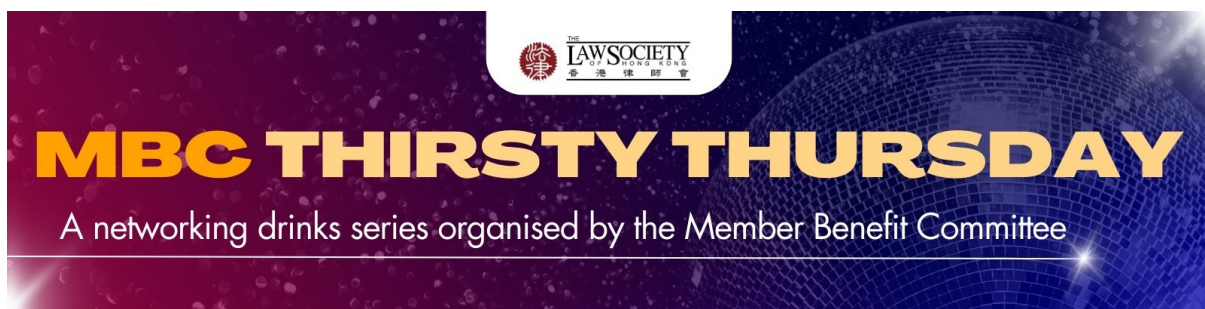
