**26-1 (SD) LAUNCH OF THE ANTI-MONEY
LAUNDERING/COUNTER TERRORIST FINANCING
COMPLIANCE SELF-ASSESSMENT FORM**

1. As the designated regulatory body under the Anti-Money Laundering and Counter-Terrorist Financing Ordinance (Cap. 615), the Law Society is committed to supporting its members in managing money laundering and terrorist-financing risks effectively. Alongside this commitment, the Law Society has a statutory duty to oversee members' compliance with the statutory Client Due Diligence ("CDD") and record-keeping requirements. To fulfil these responsibilities, the Law Society is enhancing its supervisory framework through a proportionate, risk-based approach.
2. This work is also being undertaken to address the recommendations set out by the Financial Action Task Force ("FATF") in the [Mutual Evaluation Report of Hong Kong \(2019\)](#), which called on the Law Society to establish a robust, risk-based AML supervision of legal professionals.

Mandatory Anti-Money Laundering/Counter-Terrorist Financing Compliance Self-Assessment Form ("AML/CTF Form")

3. As part of ongoing efforts to meet FATF recommendations and enhance sector-wide compliance, the Law Society is rolling out the AML/CTF Form. Completion and online submission of this form is mandatory for all law firms in Hong Kong. This requirement is based on a resolution by the Council of the Law Society. As the designated regulatory AML supervisory body, the Law Society has a statutory duty to oversee members' compliance with the AML/CTF obligations.
4. Completion of the AML/CTF Form is an important part of meeting the Law Society's professional responsibilities, and non-compliance may be treated as professional misconduct.



5. The AML/CTF Form is designed to guide firms in reviewing their own compliance with the AML/CTF requirements and to help identify areas where additional guidance or training may be useful. It will also assist the Law Society in understanding where support is most needed and in developing practical guidance and other resources for members.
6. The goal is to make compliance easier and more collaborative, to establish a shared understanding of AML/CTF requirements across the sector, support firms in strengthening their compliance frameworks, and provide an opportunity to raise questions.

How to Complete the AML/CTF Form?

- (a) **Online access to the Form:** The link for online submission of the AML/CTF Form is available on the Law Society's AML website under the “[AML/CTF Compliance Self-Assessment Form](#)” tab. Please click [here](#) to access the link to the AML/CTF Form. On the AML website, members will also find a comprehensive [Frequently Asked Questions](#) document to assist with completing the form, as well as a sample AML/CTF Form for reference purposes only. **Please note that all responses to the AML/CTF Form must be submitted online using the link provided on the AML website; submissions by email or post will not be accepted.**
- (b) **Submission Period:** 5 January 2026 – 2 March 2026
- (c) **Submission Method:** [Online only](#) (no email or postal submissions)
- (d) **Relevant Period of Self-Assessment:** 1 January 2025 – 31 December 2025
- (e) **Complete All Required Fields:** Enter your information accurately.
- (f) **Submission of the AML/CTF Form:** Click the “Submit” button at the end of the form. The Law Society will receive your submission automatically, and you will receive a confirmation email.
- (g) **Record Keeping:** Refer to the front page of the AML/CTF Form for instructions on saving your submission and making amendments if needed.

Training and Engagement Opportunities:

7. To support firms in meeting their AML/CTF obligations, the Law Society will deliver targeted training sessions starting in 2026, both on-site and through webinars or workshops. These sessions will focus on the following areas:
 - Scope of compliance and CDD requirements
 - Red flags and risk indicators
 - Suspicious transaction reporting
 - Law Society's compliance tools.
8. As part of this process, the Law Society will contact firms to arrange an AML/CTF training session. Firms are also encouraged to write to us if they would like to arrange such training or discuss a particular area in advance of our engagement.

Extension of the Pilot Scheme on Private Adjudication of Financial Disputes in Matrimonial and Family Proceedings

Amendments to Practice Direction SL9

1. The Judiciary Administration advises that Practice Direction SL 9 – “Pilot Scheme on Private Adjudication of Financial Disputes in Matrimonial and Family Proceedings” (“PDSL 9”) is to be extended for two years from 19 January 2026 to 18 January 2028. PDSL 9 has been updated to reflect the effective period of the pilot scheme and other textual changes.
2. The PDSL9, as amended in the above, will come into effect on 9 January 2026.
3. Please note that PDSL 9 will be subsequently replaced by a similar chapter in the upcoming Consolidated Practice Direction on Alternative Dispute Resolution.

26-4 (PA) HIGHER RIGHTS OF AUDIENCE (HRA) APPOINTMENT TO EXAMINING PANELS

**Extended Deadline: 9 January 2026
(Repeat circular)**

1. The Higher Rights Assessment Board (“the Board”) appoints Examining Panels for the purpose of conducting assessments of professional competence of applicants for higher rights of audience. For each assessment exercise, there are usually 2 panels, one for civil proceedings and one for criminal proceedings. Pursuant to Rule 17 of the Higher Rights of Audience Rules, each Examining Panel consists of four members. At least one member is selected from a list of not less than six solicitors submitted to the Board by the Council of the Law Society. A member of an Examining Panel holds office for a period of two years.
2. There are currently vacancies on the **Examining Panel (Civil)** and the **Examining Panel (Criminal)**. Members who would like to be considered for nomination to the Examining Panels and have a minimum of 10 years of practice experience in civil law and/or in criminal law should send their CVs to the Director of Practitioners Affairs at the Secretariat of the Law Society via email at: <mailto:dpa@hklawsoc.org.hk> marked "HRA Examining Panels" **on or before 9 January 2026**. Members should specify in their applications which Panel(s) they intend to apply for.
3. The Board indicates that if solicitor advocates wish to be considered for nomination to the panels, they should have obtained their higher rights of audience for over 5 years.
4. For members' information,
 - The Board usually conducts HRA assessments once a year. Assessments will take place over weekends. The tentative schedule for the coming round of assessments will be as follows:

<i>Criminal written examination</i>	<i>25 April 2026 (Saturday)</i>
<i>Civil written examination:</i>	<i>25 April 2026 (Saturday)</i>
<i>Criminal practical assessment:</i>	<i>9 or 16 May 2026 (Saturday)</i>
<i>Civil practical assessment:</i>	<i>9 and 16 May 2026 (Saturdays)</i>

- The Board will be able to pay honorariums to Panel members in respect of each formal assessment, that is, for examining the practical demonstrations by the candidates of their skills and advocacy coupled with their knowledge of practice and procedure, marking of the written examination papers of the candidates and preparing a report for the Board. The Board indicates that at this time, a sum of HK\$50,000 per Panel per assessment will be payable.

1. Members, preferably partners of a firm, with more than 10 years' post qualification experience are invited to apply for appointment to the Panel of Prosecutors for solicitors disciplinary tribunal proceedings ("Panel of Prosecutors").
2. Applicants should have appropriate advocacy skills and relevant experience in criminal and civil cases, particularly prosecution experience.
3. The appointment to the Panel of Prosecutors will be made on an individual basis. Appointments will be for renewable periods of two years and successful applicants will be expected to continue acting in assigned cases until their conclusion despite expiry of the term.
4. Any conduct history and/or disciplinary records of the applicants will be disclosed to the Standing Committee on Compliance for the purpose of processing the applications.
5. Members who wish to be considered for appointment to the Panel of Prosecutors should send their written application together with a resume of their experience to the Director of Conduct **on or before 7 January 2026**.

The resume should consist of not more than 2 sides of A4 paper giving contact details and particulars of practice experience.


