## **26-136 (SG) INDICATION OF INTEREST TO JOIN LAW SOCIETY COMMITTEES AND WORKING PARTIES**

1. One of the ways for members to contribute to the work of the Law Society is through active participation in the Law Society committees and working parties.
2. The Council is the governing body of the Law Society. Under the Council, there are six Standing Committees:
  - (a) **Compliance** deals with the regulatory and administrative aspects of the profession;
  - (b) **External Affairs** manages the Law Society's professional, media and community relations;
  - (c) **Member Services** enhances members' interests and benefits;
  - (d) **Policy and Resources** is responsible for policy co-ordination and management of the Law Society's resources and budget;
  - (e) **Practitioners Affairs** deals with law reforms and policies affecting the legal profession;
  - (f) **Standards and Development** maintains standards of professional practice through formulation of practice rules and training and oversees the CPD Scheme and the Overseas Lawyers Qualification Examination.

Under each Standing Committee, there are different committees and working parties responsible for specific tasks within the remit of the Standing Committee.

3. Co-option of members used to be done for individual committees and working parties at different times of the year.
4. To enable members to have an overall view of the committees and working parties that are open to co-option applications, a Circular inviting indications of interest to join any of the committees and working parties listed in the Circular will be issued on the first Monday of March and June.

**26-138 (PA) MID-TERM UPDATE OF  
THE GOVERNMENT'S MANPOWER PROJECTION**

1. The latest result of the Government's Manpower Projection was released in November 2024. The Labour and Welfare Bureau ("LWB") is now conducting the Mid-term Update to review and update the manpower projections for 2028.
2. The LWB invites members of The Law Society to participate in the online questionnaire for the Mid-term Update of Manpower Projection. This online questionnaire aims to collect views from stakeholders for the Regional Centre for International Legal and Dispute Resolution Services on manpower requirements, in-demand occupations and essential skills and knowledge over the next two years leading to 2028.

**26-139 (PA) WANG FUK COURT LONG-TERM  
HOUSING ARRANGEMENT PLAN**

**Invitation for Law Firms to Express Interest in  
Providing Legal Services to Wang Fuk Court Owners**

1. The Government announced the plan for the long-term housing arrangements for Wang Fuk Court (“the Plan”) on 21 February 2026.
2. Details provided by the Government regarding the Plan are as follows:
  - a. The Plan provides various options including the acquisition of titles from flat owners by cash, a “Flat-for-Flat” arrangement, and the reservation of flats under the Home Ownership Scheme (“HOS”), the Green Form Subsidised Home Ownership Scheme and the Hong Kong Housing Society projects for priority purchase by owners who have sold their titles. It also includes the construction of new HOS flats at Chung Nga Road West in Tai Po.
  - b. The Government will make acquisition offers to all owners of flats in Blocks A to G of Wang Fuk Court. The acquisition offer, calculated based on the saleable area, is \$8,000 per square foot for flats with premium unpaid, and \$10,500 per square foot for flats with premium paid. All the flats will be subject to the above uniform standard.
  - c. For Wang Chi House (Block H), although certain necessary repair and management arrangements must be carried out, it was not affected by the fire. Accordingly, the Government acquisition proposal does not cover Wang Chi House at this stage. However, if owners of Wang Chi House are able to reach a high degree of consensus, the Government would be willing to further explore this possibility with them.
  - d. Upon selling their titles to the Government and receiving the acquisition payment, owners may use the cash to make their own long-term housing arrangements, or they may participate in the Special Sales Exercise dedicated for Wang Fuk Court owners to purchase new subsidised sale flats afterwards.



3. In light of the implementation of the Plan and its time-bound nature, it is anticipated that Wang Fuk Court owners may require access to legal services within a relatively short period to address matters arising from the acquisition, rehousing, and related arrangements. These matters may include, among others, conveyancing as well as wills and probate issues.
4. To facilitate timely access to such legal services, the Law Society invites law firms to express interest in providing legal services to Wang Fuk Court owners. A list of interested law firms (the “List”) will be compiled for the convenience of the owners and made available on the Law Society’s website as soon as practicable.
5. While owners may continue to refer to the [Law List](#) and the [Directory of Hong Kong Law Firms](#) when seeking legal services, the List is intended as a focused resource responding specifically to the needs arising from the Plan and the circumstances faced by Wang Fuk Court owners.
6. Members are reminded that the List is compiled purely for the convenience of Wang Fuk Court owners. The Law Society’s role is limited to facilitating access to legal services and does not involve any form of recommendation, endorsement, or assessment of the law firms included.

8. No vetting of applications will be conducted by the Law Society.

## **26-140 (PA) PROPERTY**

### **Stamp Duty Ordinance Stamping of Instruments of Residential Property**

1. The Law Society received a letter dated 25 February 2026 from the Inland Revenue Department (“IRD”) on a proposal to amend the Stamp Duty Ordinance (“Ordinance”) to adjust the rates of ad valorem stamp duty (“AVD”) on **residential property** transactions with property value over \$100 million with effect from **26 February 2026**.
2. The IRD advised that a bill containing the proposed amendments will be introduced into the Legislative Council shortly.
3. According to the IRD, before the amendment ordinance is enacted, instruments relating to residential properties chargeable with the new AVD rates will be stamped by reference to the old rates within the time for stamping as usual. The additional AVD, representing the difference between the old rates and the new rates, has to be paid within 30 days commencing immediately after the date of gazettal of the amendment ordinance.

**I. Applications for the 2026 Overseas Lawyers Qualification Examination**

1. The Information Package for the Overseas Lawyers Qualification Examination (“the Examination”) in 2026 (“[2026 Information Package](#)”) and the Application Form (“Application Form”) are available on the website of the Law Society at [www.hklawsoc.org.hk](http://www.hklawsoc.org.hk).
2. Kindly note that for the 2026 Examination, applicants may elect to submit the **online Application Form** or **paper-based Application Form**. In either case, applicants are required to submit all supporting documents and information and effect payment of an application fee of HK\$6,600 by **Friday, 20 March 2026**.
3. The 2026 Information Package has been updated with the following major amendments:

**(i) Part I – Overseas Lawyers Qualification Examination**

**Section C – Overseas Lawyers Qualification Examination Information**

**(Both online Application Form and paper-based Application Form are available at the [Law Society’s website](#))**



If an applicant wishes to submit his application via online Application Form, he will pay the application fee of HK\$6,600 via online payment options including but not limited to credit/debit cards (VISA, Mastercard, Union Pay), Faster Payment System (FPS), Alipay, WeChat Pay. Details of online payment options and procedures will be provided during the online submission process.

Alternatively, if an applicant wishes to submit the paper-based Application Form, he will have to pay the requisite fee by cheque, bank draft or cashier order payable to “The Law Society of Hong Kong” as online payment options are not available for submission of paper-based Application Form.

As the Application Form contains a statutory declaration pursuant to the provisions of the Oaths and Declarations Ordinance (Cap.11, Laws of Hong Kong) (i.e. Item 30 in the Application Form), an applicant is strongly reminded to return the original Application Form with the duly executed statutory declaration together with all supporting documents to the Department of Standards and Development **on or before 20 March 2026** for processing the application no matter an applicant is submitting the online Application Form or paper-based Application Form.

### **Mode of examination for 2026 Examination**

The written Heads of the 2026 Examination (i.e. Heads I, II, III, IV and VI) (collectively, “Written Heads” and each, a “Written Head”) will be conducted **in a computer-based format**. An applicant is required to bring his own laptop computer to the Examination venue to take the Examination. An applicant has to pre-install the prescribed computer software for the computer-based Examination (“Lockdown Browser”) in his laptop computer prior to the Examination. Details of the installation and operation of the Lockdown Browser (including the taking of a practice examination) will be provided to candidates in due course.

### **A review of the Law Society’s decision under section 9 of the Overseas Lawyers (Qualification for Admission) Rules (“OLQE Rules”)**

The application fee of HK\$3,000 can be made by cheque, bank draft or cashier order payable to “The Law Society of Hong Kong” or by online payment options, details of which will be provided to applicants in due course.

### **Procedure for registration to sit the 2026 Examination**

Candidates can pay the registration fee in accordance with the Overseas Lawyers (Qualification for Admission) (Fees) Rules by cheque, bank draft or cashier order payable to “The Law Society of Hong Kong” or by online payment options, details of which will be provided to candidates in due course.



### **Withdrawal from sitting the Examination**

If an applicant is unable to take the Examination after he has been issued a Section 3(2) Certificate issued under the OLQE Rules (“Section 3(2) Certificate”) but before he has registered his intention to sit the Examination, he may apply by letter, before the expiry of the Section 3(2) Certificate, for an extension of its validity period to enable him to take the next sitting. The application fee of HK\$1,500 can be paid by cheque, bank draft or cashier order payable to “The Law Society of Hong Kong” or by online payment options, details of which will be provided to applicants in due course.

### **Computers/calculators, mobile phones etc.**

As the Written Heads of the Examination (i.e. Heads I, II, III, IV, VI) will be conducted **in a computer-based format**, an applicant is required to bring his own laptop computer to the Examination venue to take the Examination. He has to pre-install the Lockdown Browser in his laptop computer prior to the Examination. Details of the installation and operation of the Lockdown Browser will be provided to candidates in due course. He may also bring and use a silent and non-programmable calculator in the Examination. He is strongly advised not to bring any electronic/communication devices other than the laptop computer required for him to take the Examination (e.g. tablet, i-watches, smart watches, PDA, mobile phones, pagers, ear phones, ear pieces) into the Examination. If an applicant has brought along any of such devices, he must turn it off (including the alarm function) and put it under his seat in a position clearly visible to the invigilators. Failure to do so may result in disqualification.

### **Candidates with incapacities or disabilities**

Any candidate who is incapable to take computer-based Examination or suffers from a disability necessitating special requirements to sit the computer-based Examination should make an application in writing addressed to the Director of Standards and Development **not less than six weeks** prior to the commencement date of the Examination (on or before 11 September 2026):

- advising the nature of the incapacity or disability and its effect in relation to ability to sit the computer-based Examination;
- including a medical report/certificate in support; and
- specifying the special requirements requested.



The application will be considered by the Overseas Lawyers Qualification Examination Committee.

A candidate is required to provide reason(s) for any application made after the deadline of 11 September 2026. The Law Society reserves the right not to consider any late applications.

### **Application for review of applicant's script**

The application fee of HK\$3,000 per Head for a review of the answer(s)/script(s) by the Chief Examiners can be paid by cheque, bank draft or cashier order payable to "The Law Society of Hong Kong" or by online payment options, details of which will be provided to applicants in due course.

### **Section F-Guidelines for Exemption from sitting all or parts of the Examination**

#### **Meaning of "experience in the practice of law"**

If an applicant's pre-admission experience such as in-house experience has been recognised by the regulatory authority as equivalent to the completion of statutory training period and as satisfying the admission criteria in the applicant's jurisdiction of admission, the applicant must demonstrate to the satisfaction of the Law Society that such pre-admission experience is comparable to the training required for admission and/or is relevant experience in the practice of law and that documentary evidence of attaining relevant experience in addition to the recognition of such pre-admission experience by the regulatory authority of the applicant's jurisdiction of admission must be provided.

### **Section G-Application Form**

In view of the introduction of online Application Form and online payment options, the Personal Information Collection Statement in the Application Form has been revised. Consequential amendments to Items 29 and 30 of the Application Form have also been revised.

## **26-143 (EA) KOREAN INTERNSHIP PROGRAMME 2026**

### **(Repeat Circular)**

1. Building on the success of the internship programmes jointly organised with the Korean Bar Association and the Korean Ministry of Justice since 2014, the Law Society will continue the two-week Korean Internship Programme in 2026.

#### **Inbound Programme (Korean interns to Hong Kong)**

2. This year's inbound programme will take place from 3 to 14 August 2026. The Law Society calls on support from our members' law firms and legal unit of corporations to host the selected English-speaking Korean interns. The interns will ensure their own compliance with the Hong Kong training visa requirements, with the Law Society as the sponsoring company. They will also bear all travel and accommodation expenses related to their participation in the programme. No remuneration is payable for the internship.
3. While the Law Society will tentatively organise orientation and networking activities on the first day (3 August 2026) and last day (14 August 2026), participating law firms and corporations are expected to provide their own training programmes for the interns during their stay, including but not limited to practical work assignments with the law firm/corporation, visit(s), meeting(s), professional exchanges, networking activities, and/or other meaningful exposure to Hong Kong's legal profession.

#### **Outbound Programme (Hong Kong interns to Korea)**


