## 26-352 (PA) PROPERTY

### Stamp Duty (Amendment) Ordinance 2026

1. The Inland Revenue Department informed the Law Society that the Stamp Duty (Amendment) Ordinance 2026 (“Amendment Ordinance”) has been published in the gazette on 29 May 2026 (“Gazettal Date”). The Amendment Ordinance increases the ad valorem stamp duty (“AVD”) rate for instruments of **residential property** with value above \$100,000,000 from 4.25% to 6.5% with effect from **26 February 2026** (“Effective Date”).
2. Regarding instruments of residential property with value above \$100,000,000 executed on or after the Effective Date and already stamped before the Gazettal Date, the time for paying additional stamp duty, that is the difference between AVD calculated at the rates of 4.25% and 6.5%, is within **30 days commencing immediately after the Gazettal Date**.

## 26-358 (SG) INDICATION OF INTEREST TO JOIN LAW SOCIETY COMMITTEES AND WORKING PARTIES

1. One of the ways for members to contribute to the work of the Law Society is through active participation in the Law Society committees and working parties.
2. The Council is the governing body of the Law Society. Under the Council, there are six Standing Committees:
  - (a) **Compliance** deals with the regulatory and administrative aspects of the profession;
  - (b) **External Affairs** manages the Law Society's professional, media and community relations;
  - (c) **Member Services** enhances members' interests and benefits;
  - (d) **Policy and Resources** is responsible for policy co-ordination and management of the Law Society's resources and budget;
  - (e) **Practitioners Affairs** deals with law reforms and policies affecting the legal profession;
  - (f) **Standards and Development** maintains standards of professional practice through formulation of practice rules and training and oversees the CPD Scheme and the Overseas Lawyers Qualification Examination.

Under each Standing Committee, there are different committees and working parties responsible for specific tasks within the remit of the Standing Committee.

3. Co-option of members used to be done for individual committees and working parties at different times of the year.
4. To enable members to have an overall view of the committees and working parties that are open to co-option applications, a Circular inviting indications of interest to join any of the committees and working parties listed in the Circular will be issued on the first Monday of March and June.
5. Regular appointments to committees and working parties will be made in October every year. There may also be ad hoc appointments to certain committees and working parties during the year (e.g. where a causal vacancy arises as a result of the retirement of a member).



6. Indications of interest received in response to a co-option Circular during the year will be collated for consideration in the first co-option exercise that follows the receipt of indications. All information received will be retained until the completion of that co-option exercise. The conduct history and disciplinary records of the applicants may also be reviewed in the co-option process.

1. On 21 February 2026, the Government announced the Wang Fuk Court Long-Term Housing Arrangement Plan (the “Plan”) for owners of Blocks A to G of Wang Fuk Court (“WFC”). In response to the strong consensus initially reflected among Wang Chi House (宏志閣) (Block H, WFC) owners to join the Plan, the Government further announced on 28 April 2026, that, if 75% or more of the owners of Wang Chi House confirm their intention to sell their titles to the Government on or before 30 June 2026, the Plan already in place for the rest of the estate will also be extended to Wang Chi House.
2. The Law Society has recently been invited by the Housing Bureau to host a briefing session to deepen members’ understanding of the Government’s proposed acquisition of units in Wang Chi House (the “Offer”), including specific conveyancing matters. 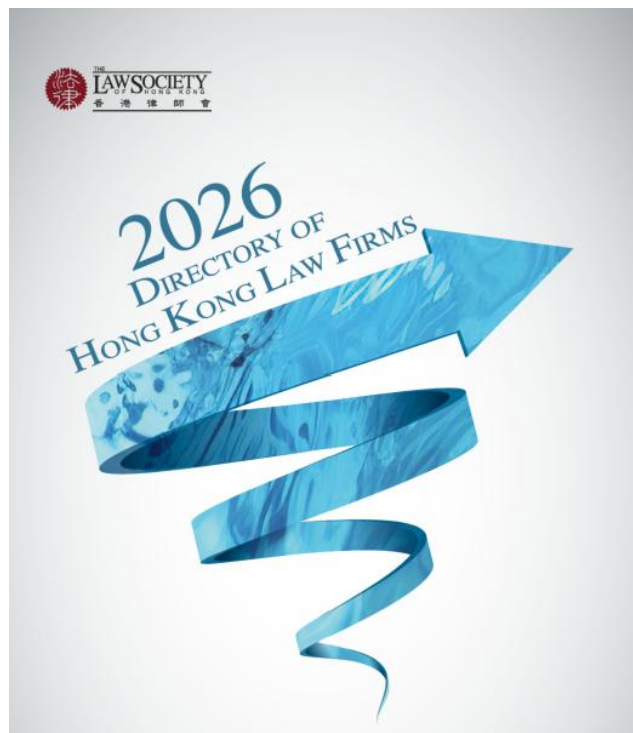
