**26-370 (PA) DEVELOPMENT OF UNCERTIFICATED
SECURITIES MARKET (“USM”) REGIME**

1. The Securities and Futures Commission (“SFC”) informed that the SFC has, on 29 May 2026, published a Guidance Note to assist securities issuers with preparing to participate in the USM regime, which is targeted for launch on 16 November 2026.
2. The Guidance Note identifies key areas of focus and provides sample provisions for issuers’ reference. Issuers will need to complete their amendment exercise by the first anniversary of USM launch (i.e. by 16 November 2027) or by the date of their first annual general meeting after USM launch, whichever is later. Issuers are therefore encouraged to start this process as soon as possible.

26-372 (EA) MAINLAND AND HONG KONG CLOSER ECONOMIC PARTNERSHIP ARRANGEMENT (CEPA) HONG KONG-INVESTED ENTERPRISES CHOOSING TO APPLY HONG KONG LAW AND CHOOSING HONG KONG AS SEAT OF ARBITRATION

1. Under the “one country, two systems” principle, Hong Kong possesses a unique advantage as the only common law jurisdiction in our country. The Department of Justice (“DoJ”) has been actively promoting and strengthening Hong Kong’s competitiveness as an international legal and dispute resolution services centre, with a view to attracting investors, including Mainland enterprises, to utilise Hong Kong’s legal and dispute resolution services.

“Allowing Hong Kong-invested enterprises to adopt Hong Kong law” and “allowing Hong Kong-invested enterprises to choose for arbitration to be seated in Hong Kong” are two of the main initiatives in this respect. The initiatives were also included in the Second Agreement Concerning Amendment to the Mainland and Hong Kong Closer Economic Partnership Arrangement Agreement on Trade in Services signed in October 2024 as facilitation measures for Hong Kong investors.

2. Since February 2025, the scope of these measures has been extended to additional Mainland municipalities. At present:
 - the adoption of Hong Kong law is applicable to Hong Kong-invested enterprises established and registered in Shenzhen and Zhuhai; and
 - the choice of Hong Kong as the seat of arbitration is applicable to enterprises in the Pilot Free Trade Zones in the Mainland and the nine Mainland municipalities within the Guangdong-Hong Kong-Macao Greater Bay Area.
3. After the extension, Hong Kong-invested enterprises established and registered in the relevant municipalities can be benefitted regardless of their ratio of investment.
