**26-407 (PA) ROLLOUT OF E-APPOINTMENT SERVICE FOR
APPLICATION FOR REGISTRATION OF
ENDURING POWER OF ATTORNEY**

1. The Judiciary informed that the e-Appointment service will be extended to applications for registration of Enduring Power of Attorney (“EPoA”) in the High Court Registry from 3 July 2026 (Friday), for the booking of appointments from 6 July 2026 (Monday).
2. **With effect from 6 July 2026 (Monday)**, when attending the High Court Registry to submit an application for registration of an EPoA, the Donor and/or his/her Attorney(s) of the EPoA, or their solicitors, are required to book an appointment in advance. **Walk-in applications will not be accepted.** The applicant will have to book an appointment for another day, unless there are remaining timeslots in the afternoon of the same day.
3. Please click [here](#) for the Judiciary’s e-Appointment system to book appointments up to 30 days in advance. Each appointment timeslot is for registration of **one EPoA**. Each solicitors’ firm may book an appointment for a maximum of four timeslots and up to four timeslots per day.
4. To facilitate processing of applications, **with effect from 6 July 2026 (Monday)**, when submitting an application for registration of an EPoA, the solicitors representing the applicant is required to **specify in the covering letter, whether any variations or additions have been made to clauses 2 and 3 of Part A of the prescribed Form 1 or clauses 3 and 4 of Part A of the prescribed Form 2 under the Enduring Powers of Attorney (Prescribed Form) Regulation (Cap. 501A).**

26-412 (MS) FREELEGALLINK RECRUITMENT OF PRO BONO LAWYERS AND TRAINING WORKSHOP

1. FreeLegalLink (the “Scheme”) is jointly initiated by The Office of Dr Thomas So Shiu-tsung JP, Legislative Council Member, and eBRAM International Online Dispute Resolution Centre Limited, and supported by the Agency for Volunteer Service. The Law Society of Hong Kong is one of the Supporting Organisations of the Scheme.
2. The Scheme helps those in need of access to legal assistance on everyday legal problems efficiently and conveniently, combining legal expertise and technology for the public good.
3. Initially, the Scheme will be open to enquiries from the public received through Legislative Council Members Offices with broad community connections. Legal assistance is provided online via the eBRAM's Deal-Making Portal and is capped at 45 minutes per enquiry.
4. Assistance is expected to involve oral advice, document review, and document drafting where considered necessary. Court appearances on behalf of the enquirer are not envisaged under the Scheme. The Scheme will start with handling enquiries relating to the following areas:
 - a) Estate planning issues, including wills, enduring powers of attorney, and advance medical directives
 - b) Employment disputes
 - c) Tenancy and property related matters
 - d) Family matters, including divorce, maintenance, and custody
 - e) Building management problems, including water seepage
 - f) Advice on criminal matters
5. The FreeLegalLink Training Workshop will be organised on 13 July 2026 for participants to master the necessary technological skills, enabling participants to help those in need of legal assistance efficiently, conveniently and safely via eBRAM's advanced online communication platform.

1. In recent years, the Northern Metropolis has become a major impetus for Hong Kong's future development and a key platform for integration with the Greater Bay Area. As underscored by the recent two-day visit of Xia Baolong, Director of the Hong Kong and Macao Work Office—which focused on Hong Kong's alignment with the nation's 15th Five-Year Plan and the ongoing development of the Northern Metropolis—this initiative has been elevated to a strategic level within national planning. Against this backdrop, the progressive rollout of policies, industry initiatives, and cross-boundary investment mechanisms is expected to generate significant opportunities.



2. These developments will, in turn, give rise to a growing demand for legal expertise in areas such as investment structuring, regulatory compliance, financing, and dispute resolution. As the Government rolls out dedicated legislation, streamlines planning procedures, and introduces preferential policy packages to attract strategic enterprises, legal practitioners will face an increasingly complex regulatory environment.

In light of the significance of this transformative initiative to the legal profession, The Law Society of Hong Kong and the Office of Dr Hon Thomas So Shiu-tsung, JP, Member of the Legislative Council (Election Committee), will co-organise a Forum on “Northern Metropolis: Investment Opportunities and Related Legal Issues” on Friday, 17 July 2026.
