It aims to facilitate the transformation of innovative outcomes, promote the establishment of diverse dispute resolution mechanisms through pilot programs, and provide high-quality, efficient, and convenient dispute resolution support. 	construction of the Greater Bay Area as an internationally influential science and technology innovation centre through collaborative, co-constructed, and shared mechanisms.

14:10 - 14:50	<p>议题二 贸仲漫谈：贸仲 2024 版仲裁规则剖析和区内实务展望 Session Two: CIETAC Discussion – Dissection of CIETAC's 2024 Arbitration Rules and Practical Outlook in the GBA</p> <p>本环节将由贸仲 2024 版仲裁规则修订工作小组的专家、贸仲及区内国际仲裁机构代表等以对谈访问的形式，深入剖析和解读贸仲 2024 版仲裁规则的修订亮点及背后的考量，并从案件受理、仲裁庭管辖权、仲裁案件的处理效率等方面展望规则修改给大湾区商事仲裁实践带来的新变化，在《内地与香港法院互相认可和执行民商事判决安排》与仲裁相关系列安排横向比较的背景下进一步分析规则修改给当事人及代理人在案件处理的公平性和透明度、财产保全、第三方资助等方面带来的“用户体验”提升。</p> <p>This session, presented in the form of a dialogue between experts of the 2024 Arbitration Rules Revision Working Group and representatives from CIETAC and other international arbitration institution in the region, will delve into the highlights of the revision of CIETAC's 2024 Arbitration Rules and the considerations behind them. It will also discuss the new changes the rule modifications will bring to commercial arbitration practice in the Greater Bay Area, looking at case acceptance, jurisdiction of the arbitral tribunal, and the efficiency of handling arbitration cases. The discussion will further analyse the impact of rule modifications on the fairness and transparency of case handling, property preservation, third-party funding, etc., for parties and representatives in the context of a comparative analysis with the "Reciprocal Recognition and Enforcement of Civil and Commercial Judgments between Hong Kong and the Mainland " and related arbitration arrangements.</p>
