- 11. In August 2025, I undertook a duty visit to India, where I spoke at the 35th Summit of Presidents of Law Associations of Asia (POLA) and the 2nd New Delhi International Rule of Law Convention. There, I joined fellow international speakers in addressing the complex challenges posed by emerging technologies such as artificial intelligence and social media, emphasizing the critical importance of safeguarding legal ethics and integrity in the digital age.
- 12. Most recently, I attended the Opening of the Legal Year 2025 in England and Wales, meeting with senior representatives of the Solicitors Regulation Authority (SRA). Our discussions focused on the evolution of legal practice structures, pathways for solicitors in both jurisdictions, and the growing impact of technology on legal practice.
- 13. These exchanges have reinforced our shared commitment to building bridges across legal systems, fostering mutual understanding, and promoting regulatory excellence and innovation.

#### **Conference Theme and Global Relevance**

- 14. The theme of this year's Conference, "New Ways to Regulate in a Changing World?", is both timely and globally relevant.
- 15. We are witnessing a period of profound transformation in the legal landscape. The rise of artificial intelligence, the proliferation of digital platforms, and the increasing complexity of cross-border legal practice are reshaping how legal services are delivered and how they must be regulated.
