- 8. Today, I address you as President of the Law Society, but I also speak as someone who has practiced as an in-house lawyer for nearly two decades. I would like to share some reflections that I believe will resonate with many of you.
- 9. As in-house lawyers, we are uniquely positioned to bridge the gap between legal risk and business innovation. We understand the regulatory landscape, commercial realities, and ethical imperatives. We are not merely advisors—we are strategic enablers, guiding our organizations through digital transformation.
- 10. The theme of today's conference, "The Future of Lawyers:

 Innovation, Strategy, and Resilience" could not be more timely or

relevant.

- 11. We meet at a pivotal moment in the evolution of our profession. The legal world is undergoing a profound transformation driven by technology, which is reshaping how legal services are delivered, consumed, and understood. At the heart of this transformation lies a critical question: How do we, as legal professionals, remain **relevant**, **resilient**, and **responsible** in an age of rapid innovation?
- 12. At the Law Society, we are committed to supporting you on this journey.

 This conference is a testament to our recognition of your contributions and our dedication to equipping you with the tools and connections to excel.

the responsible adoption of AI for the benefit of our profession.

- 14. In-house lawyers are increasingly taking on the role of champions of innovation within the organisations, acting as both legal advisors and risk managers. We are expected to do more with less, move faster, and deliver legal solutions that are both reliable and scalable.
- 15. With this in mind, the Law Society will continue to explore AI adoption in collaboration with a diverse ecosystem of stakeholders, supporting the advancement of the legal profession and ensuring we remain future-ready.
- 16. This year, we are excited to introduce a new afternoon stream focused on AI for lawyers, titled *Futuristic in Practice All-in-AI showcase*, featuring speakers from LawTech solution providers and innovators, such as Datasite, Canon, Lineal, Google, and LawPlus.
- 17. The parallel stream, "In-House Agility," will feature distinguished speakers discussing the latest legal developments and regulatory

changes.

- 18. I understand that choosing between these two streams will be challenging. Rest assured, our In-House Lawyers Committee will continue to foster exchanges and collaboration, supporting our members as always.
- 19. The future of law is not something that will simply happen to us. It is something we must co-create with courage, curiosity, and a deep commitment to our core values.
- 20. I would like to express my heartfelt gratitude to all our esteemed panelists for sharing their time and insights, to our sponsors for their generous support, and to the In-House Lawyers Committee for organizing today's program.
